Our Benefits Remain at Risk

Congress has approved increasing tax rates on the wealthiest Americans but this alone is only a small part of what is needed to produce a balanced budget for 2013 AND contribute to reducing the accumulated deficit. Congress is exploring many additional options to increase income such as closing loopholes in taxes, reducing entitlement programs and cutting back on federal employment and benefits. And the goals of NARFE are on the table and being scrutinized as a means to reduce federal spending. That includes all of us!!

The Congressional Budget Office published a study comparing the compensation of Feds and private-sector employees based on data from 2005-2010 and found, in some cases, feds are paid more than private-sector employees with similar characteristics. But that simple finding can be misleading. For example, the CBO study found that for the most highly educated, Feds have salaries that are 23% less than private-sector workers with similar characteristics.

The CBO methodology used ignores some facts and includes irrelevant factors for setting pay. The CBO study does not take into account the level of job responsibility, specialized training and length of tenure with an employer, all of which employers take into account when determining pay. When comparing pay for similar jobs (rather than for individuals with similar training) the nonpartisan Bureau of Labor Statistics (BLS) data show that Fed jobs pay 26% less than similar private sector jobs.

NARFE is particularly concerned about the outcome of six important issues:

- **Our Annuity contribution** - The idea of forcing Feds to pay an extra 1.5% into their retirement is essentially a new tax. As part of the payroll-tax holiday and an employment benefits extension deal, newly hired Feds will al-

ready pay 2.3% more. Workers in the private sector with benefits are not required to contribute toward that retirement.

- **High-Five vs. High-Three** - If the retirement system is changed to use an employee's highest 5 years of salary, it will reduce a Fed's retirement monthly income, which could amount to cuts of \$2000 to \$7000 over the next five years.
- **Ending FERS Supplement** - One third of FERS employee's retirement is a social security benefit. Some become eligible for retirement prior to age 62 when they can begin collecting Social Security. The supplement is the additional annuity FERS retirees may receive until they are eligible for the Social Security portion of their retirement benefits. Removing the FERS Supplement would reduce the median FERS annuity from \$425 to \$270 per month.
- **Extending the Pay Freeze** - Feds have already contributed \$60 billion to deficit reduction through a two-year pay freeze. Extending the freeze would widen the gap between Feds and their counterparts in the private sector, and lose our most experienced workers to higher-paying jobs in the private sector.
- **Health Insurance Premiums** - A proposal under consideration would see our premium contribution increase from 30% to 43%, which translates to an increase of \$2,850 by 2020.
- **And finally, COLA's** - the Fiscal Commission recommended changing the current COLA adjustment index to the "Chained CPI." It does not factor in real inflation and does not reflect the disproportionately higher health care costs paid by older Americans. This will result in lower COLA's and be compounded year by year.

NARFE-FEEA SCHOLARSHIP AWARDS PROGRAM

In 1987, the Federal Employee Education & Assistance Fund (FEEA) established a scholarship program for children and grandchildren of federal employees. NARFE became a member of FEEA's board of directors in 1997, and the following year NARFE's National Executive Board authorized the creation of a scholarship fund open to the children, grandchildren, great grandchildren and stepchildren of NARFE members. The NARFE-FEEA Scholarship Awards Program is supported by NARFE members and administered by FEEA. A total of \$787,000 has been awarded in scholarships to the children, grandchildren, great grandchildren and stepchildren of NARFE members (as of 2012).

The next program begins on February 1, 2013, and will end on April 26, 2013. The official 2013 scholarship application will appear in the February issue of NARFE magazine and will be available

for downloading from the NARFE website February 1-April 26. NARFE plays no role in the compilation, dissemination, judging or notification of winners in the competition. Winners will be notified by FEEA. All applicants will receive a letter from FEEA thanking them for their participation.
