### KEY FOCUS BILLS BEFORE CONGRESS THAT WOULD REDUCE BENEFITS

**I**n the June and September issues of this newsletter I briefly described about 11 House Bills and 8 bills before the Senate that would have affected Federal employees and retirees if enacted. Here I provide an update on the status of many of those 19 bills. Some of them may be acted upon during the lame duck session by the current Congress between election day and December 31. Some are no longer under consideration but relevant portions are included as a part of newer bills with different numbers. Given the upcoming election, it's anyone's guess as to what will happen with these bills when the new Congress convenes after January 1 if not acted upon by the lame duck Congress.

In a recent on line updated report, NARFE has now identified 4 Senate bills and 5 House bills known as 'Key Focus Bills' (KFB) because they focus primarily on us Feds and are not a small part of some major bill on other subjects. NARFE supports some of these Key Focus Bills and opposes others.

Among these KFBs is S. 644, which would eliminate the defined annuity entirely for federal workers hired after 2012 (which has been in place for the past 90 years). NARFE opposes this bill. Some 6 House bills and 3 Senate bills propose to decrease the size of government by 5 to 15% and have been referred to various committees. Among these are KFB S. 2065 and companion bill H.R. 3662 which would extend the two-year pay freeze through June 2014 for civilian employees, restrict hiring for five years, and fill 2 positions for every 3 vacancies. NARFE opposes this bill also. Another KFB is S. 2196 that would phase out the Medicare program and move the entire Medicare population into the FEHB program, which would cause an increase in premiums for Feds and retirees, and threaten the affordability of health coverage for seniors. It would also increase the eligibility age to 70 and require wealthier retirees to pay higher premiums; NARFE opposes these also.

On the House side is KFB H.R. 2465 which was passed by House vote and which NARFE supported. This bill streamlines the claims process. It insures that workers receive adequate compensation, improves integrity and modernizes benefits.

KFB H.R. 3813 increases current employee contribution under both CSRS and FERS; changes annuity calculation and eliminates FERS Annuity supplement. It was reported favorably by Committee in February. NARFE opposes this bill.

Another KFB H.R. 3835 is a pay freeze extension of the current 2-year freeze and includes members of Congress. It was passed by the House; NARFE opposes this bill.

A newer KFB is H.R. 5652 known as the Sequester Replacement Act. It would increase CSRS and FERS employee contributions toward their retirement by 5% of salary over 5 years beginning in 2013. KFB H.R. 2309 would overhaul the U. S. Postal Service and establish a commission on Postal Reorganization as an independent commission to do this.

Finally, there is a Congressional Resolution #112 for FY 2013 which would extend the pay freeze for 3 years and increase retirement contributions. It includes instructions to 6 House committees including the House Oversight and Government Reform. It was passed by the House; but a Senate Motion to proceed was rejected.

If you have an opinion on any of these Key Focus Bills before the election, now is the time to let your political officials know. The phone numbers are in every issue of this newsletter.

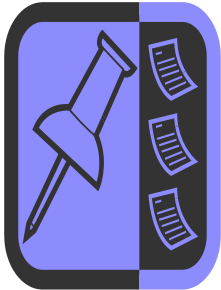

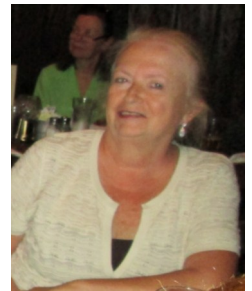
Congratulations to newly elected officers Richard Bennof and Elaine Cameron

## NARFE 32nd National Convention Report

Arriving late Sunday evening in Reno was my first mistake. I entered a door labeled Registration, but found an empty Lobby. Finally saw someone to assign me a room. I walked and walked to get to this room, then had trouble with the card unlocking the door, finally got it to work. Had nothing to eat all day except a few pretzels on the airplane, but was too tired to look for eats, so relied upon a couple of shot size bottles of bourbon and went to bed.

This hotel was super-size. I am a walker, but got annoyed at the distance we had to walk to meetings and restaurants. There must have been 3,000 slot machines in this hotel, everywhere except in your bathroom. Since there was no alternative I went to breakfast in the hotel. Breakfast was \$12 and other meals were also expensive. Good thing I don't eat a lot.

The meeting took place in a large room, seating 1,100 people at tables. We were revising the bylaws, and all was well organized. When a bylaw was suggested, anyone had the opportunity to speak for or against it. Our people from headquarters did a most impressive job of conducting this convention.

The first speaker on Monday morning was John Berry, head of OPM. He is a nice looking young man with a winning smile, and I thought, Oh no, another Politician. After he spoke of some of his accomplishments I had a much better opinion of him. He is a NARFE member and

seems to have a close relationship with NARFE's President Joseph Beaudoin. He reported about increasing the number of veterans employed by the government from 24% to 28%. He also reported increasing the number of disabled persons employed by the government. He ended his talk by saying that we were the generation that ended segregation, put a man on the moon, stopped the communist threat to world power, and gave us the internet.

All national officers were reelected, as there were no opposing candidates. There was an interesting contest for Region II Vice President, our region, which includes Maryland, Pennsylvania, Delaware, New Jersey, and the District of Columbia. This is a paid position, paying about \$23,000 per year, I believe. We had three candidates from the MD Federation, Ron Bowers, the current Vice President, Barry Greer, and Evelyn Kirby running for office. I was close to Ron, supporting him when he ran for this position, but recognized that Evelyn Kirby had much to offer. I had 12 votes, one vote for every 50 members in our chapter, so I split my vote, 6 to Ron, and 6 to Evelyn Kirby, who was elected.

The convention was most impressive and I hope other members of the executive board will attend in the future. The next one will be in Orlando, FL in 2014.

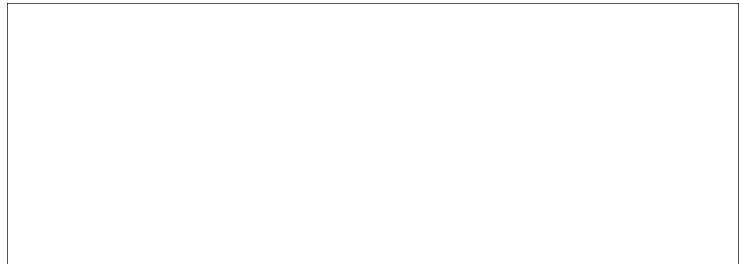
