**ANNUAL LEGISLATIVE FORUM**

The Maryland General Assembly meets for ninety days each year to act on a large number of bills including the State's annual budget. If you're interested in what happened during the 428<sup>th</sup> Session, join us at our April meeting. Each year we invite our local senators and delegates to a Legislative Forum to hear about decisions that were made and what to expect in the future. Most of the invited legislators join us at the luncheon held before the meeting, giving us an additional opportunity for interacting with them.

**PRESIDENT'S MESSAGE... *Mary Anne Scott***

By now most of you have received your April issue of the NARFE magazine. I strongly urge you to read the cover story carefully and respond accordingly. NARFE has initiated a national campaign, with a slogan of "Protect America's Heartbeat," to fight drastic cuts in pay, health, and retirement benefits of active and retired federal workers.

It seems that every week brings another assault on federal workers. Most recently, a bill (S. 644) was put before Congress that would eliminate pensions for all new federal employees. NARFE President Joe Beaudoin responded with a strong statement that included this quote: "Changes to policies that affect federal employees threaten the future of the vital services they perform. Without employment packages that are competitive in the professional marketplace, our government will struggle to attract the best workers to protect us." We cannot expect NARFE headquarters to bear the full burden of responding to these threats. We have to do our part.

A recent telling quote from a Marylander member of the State Legislative Committee stated, "Legislators tell us that a quiet constituency is a contented constituency and we are very quiet. Witness the number of subscribers to GEMS, the number who respond to calls from HQ for members to visit/communicate with their senators and representatives." It is past time to set aside our complacency and become our own best grassroots advocates. The national campaign referred to above provides a vehicle to help us do that - especially since Maryland is one of the eleven priority states selected for focus in that campaign. One of the elements of that campaign is "telling our stories." I'm sure among our over 1,300 members there are some great stories of contributions made to the health and well-being of the general population that have gone unremarked for too long. **FEDERAL LEGISLATIVE REPORT**

We now have had six short term continuing resolutions to keep the Government running. These involved agreement on cuts of some billions of dollars to the Federal budget for the current fiscal year which ends in September. However, patience is running out on short term solutions and it remains uncertain what kind of compromise might be acceptable to stop the Government from being shut down.

In addition, the current Federal debt limit will be breached in the very near future and there will be severe economic consequences if there is no agreement for it to be raised. Hence this is another area of contention that will feature in the compromises that finally emerge from our polarized politics.

Although the squabbles over this year's Federal budget and, towards the end of the year, the proposals for next year's budget are of major concern to the Federal Community, these issues contribute little to reducing the national debt. This topic affects every citizen and is likely to be a major election issue alongside concerns about the economy and unemployment. Hence both political parties are proceeding very cautiously in addressing possible solutions to the debt issue to avoid being disadvantaged by being associated with proposed policies that are poorly received by the electorate.

NARFE has plans to improve the reputation of the Federal Community by a project called "Protect America's Heartbeat" which is described in the April edition of the NARFE Magazine. The objectives are to counter misinformation about the pay and benefits of federal employees and to clarify the many contributions made by the Federal Community to the smooth and safe running of the country, both of which are often not recognized by the general public or by some politicians. This campaign will extend down to chapters, with members requested to contribute examples from their careers which can illustrate our contributions.

Three hundred members from across the country attended a Legislative Conference in Arlington, VA, recently where we were brought up to date on the threats facing us and the evidence to use in our defense. On the last day we visited our Senator's and Representative's Offices, many of whom had contributed to the Conference, speaking in defense of the Federal Community. We look forward to sharing the results of our campaign with them, so that we do all we can to help them defend our interests.

**STATE LEGISLATIVE REPORT**

The Maryland State Legislature has yet to come to grips with the financial problems of the State. Governor O'Malley submitted a budget that relied heavily on borrowed funds and increased fees. At this time it looks like the fees will be raised and borrowing increased but the critical issues facing the State will either be put off until next year or will be dealt with in a special session. In the meantime the legislature is spending a great deal of time on issues that do not have price tags attached. These have ranged from the controversial same sex marriage bill to a bill to allow patrons of outdoor restaurants to bring their dogs along with them. Again, anything is possible with our State Legislature and everyone needs to stay vigilant and make their opinion known to their legislative representatives. The State Legislative Committee continues to be vigilant and is making every effort to advance the NARFE agenda.

The Chapter is now planning its annual legislative forum for April 26<sup>th</sup>. On that day we will be having a lunch starting at 11:30a.m. followed by our Chapter meeting at 1p.m. State Senators and Delegates from our chapters have been invited and we hope for a good turnout of both legislators and members. It will be very interesting to hear their assessment of the year's session and their opinions as to what still needs to be done. We look forward to seeing as many of our members as possible at the Legislative Forum. Come armed with questions you would like answered during the Questions and Answers portion of the forum.

## NARFE PAC

The March edition of the NARFE Magazine highlighted the need for contributions to NARFE PAC, which is a political action fund financed exclusively by donations from individual NARFE members. The proceeds go, in the form of contributions up to \$5,000.00, to deserving Representatives and Senators who have made themselves accessible to us and who have consistently supported our causes and defended our interests. NARFE may also contribute to a candidate in a close election who is markedly more sympathetic to our concerns than the opponent.

Members are encouraged to donate using a form printed in the NARFE Magazine or at a NARFE event, such as a Membership Meeting or Federation Convention. Donations of \$20, or more, entitle the donor to request a NARFE PAC pin which can be worn with pride.

In the 2009-2010 cycle donations of over \$1,300,000.00 were made by NARFE members nationwide, with our District II as the highest contributor, led by the Maryland Federation. We hope that we will repeat this leadership role by our members being equally generous during the 2011-2012 cycle.

## RETENTION REPORT

Maryland NARFE has undertaken three activities to increase membership retention. Last November, Maryland NARFE sent 473 personalized letters to a group of lapsed Members. It informed them that they could save money by rejoining before January 1, 2011, when the new dues increase would take effect. By the end of February, 42 of these lapsed members had re-joined for a total of 70 membership years, a very good success rate. This mailing cost Maryland NARFE about \$525; it returned revenues of almost \$1,850 in national dues and about \$250 in chapter dues. The Federation will recover the cost of the mailing in about three years.

Early in February, Maryland NARFE put its new Dues Withholding Incentive Program (DWIP) into effect with the first of a series of monthly mailings to groups of recent members whose memberships are about to expire. The personalized letters offer recipients a rebate of \$5.00 if they sign up for dues withholding when they rejoin. The rebate is in addition to the 15 percent discount they receive on national dues by going on dues withholding. With the automatic deduction of dues from annuity payments, Gaithersburg chapter members will pay \$3.50 per month to cover both annual chapter dues and the discounted national dues of \$34.00. Members can sign up for dues withholding at any time by using the form in NARFE magazine (January issue, page 49) or from the NARFE web site, [www.narfe.org](http://www.narfe.org). It will go into effect at the end of their current membership term. Once they have signed up they will never again receive a dues notice.

Also in February, Maryland NARFE started sending personalized letters to lapsed members whose membership expired about nine months earlier. These letters invited them to rejoin and provided application forms for reinstatement and for dues withholding. Similar letters to lapsed members will go out each month in a pilot program to see how effective this approach is.

Early results from the two monthly mailings will be available at the Biennial Convention on May 2-3, 2011.

**NEB MEETING IN MARCH**

On March 2 and 3, 2011, I attended the meeting of the National Executive Board (NEB) as an observer. It was held at the Crystal City Hyatt in Arlington, VA. The members made a number of major decisions and some lesser ones that are described in this report, along with comments and updates.

Note that all of the members of the NEB attended both days I was there, with the sole exception of National Treasurer Charley Saylor. Pres. Joe Beaudoin reported he was in the hospital undergoing tests. [As we know by now, our friend and long time NARFE leader Charley Saylor died on Monday, March 7, 2011.]

**Financial matters**

President Joe Beaudoin reported that NARFE's finances at HQ are running in the red and probably will be until next October. It will take time to remedy NARFE's finances from the increased revenues resulting from the increase in National dues that was fully implemented on March 1.

The NEB decided to hold NARFE's first general fundraising campaign to pay for its aggressive actions to oppose the ongoing attacks on the earned retirement benefits of active and retired federal employees. See the paragraph below on "Legislative matters." The fundraising campaign will start as soon as possible.

After hearing a report from two members of the NARFE Information Tech Advisory Committee (NIAC) about the obsolete nature of NARFE computing equipment, the NEB decided to begin replacing equipment as funds permit, following the NIAC's recommendations. Maryland NARFE's Pat Dempsey was one of the two NIAC members.

The NEB decided to allocate the 10-percent rebates from \$40 National dues of members of the new eNARFE national chapter to federations according to the Zip Codes of the new members. There are no chapter dues for eNARFE members. The eNARFE chapter is all electronic; it has been established under the NEB's authority to offer incentives for membership recruitment and retention. See the report on eNARFE below for more information.

**Membership matters**

NARFE HQ is mounting three recruitment by mail campaigns during March. The first is the semi-annual mailing to the OPM blind mailing list of recent

The Council will meet again on April 13<sup>th</sup> to continue planning for this late July event.

employee and survivor annuitants; it will go to some 40,000 recent annuitants. This is the single most important source of new members for NARFE. The second is a mailing to some 50,000 names on a mailing list rented from Government Executive magazine. The third is a one-time mailing to approximately 20,000 dropped members whose membership lapsed in 2009 for non-payment of dues. The mailings will offer membership in **eNARFE** where it is appropriate, presumably in the first and second mailings.

NARFE's new electronic chapter, Chapter 2363, also being described as **eNARFE**, is in the process of being formulated but a number of decisions have already been made about it. Members will receive NARFE magazine but no other paper. All other communications will be made by email, including GEMS messages, and other electronic media. A blog will be established for this chapter so that members can exchange ideas on NARFE issues. [This may be a pilot for a blog to be used by all NARFE members who have internet access.] Voting procedures for members of this chapter is one of the issues to be addressed at the NEB meeting in July. Members can learn more about **eNARFE** from the web site [www.narfe.org](http://www.narfe.org). It is also discussed in the April issue of NARFE magazine.

This chapter has no dues and members pay only \$40 instead of the \$45 paid by other new members. Some members of the NEB were concerned that most of the new members would choose to be **eNARFE** members instead of members of "traditional NARFE" and that current chapter members would transfer to **eNARFE** to avoid paying chapter dues. A motion was made, seconded, discussed, and approved to permit only new members to join **eNARFE**; however as this policy violates the Bylaws provision that any member may join any chapter it was subsequently voided.

The first concern, that new members would opt to go into **eNARFE** instead of "traditional NARFE," with its chapter structure, was left unaddressed. In 2010, Maryland NARFE chapters received 600 new members from the OPM mailings. In 2011 and 2012 a similar number of new members would bring in about \$10,000 in revenues to chapters. If most of those new members choose to be **eNARFE** members the current chapters would not receive that increased revenue. More importantly, they would not receive the influx of

new members needed to keep chapters in operation in the long run.

### **Legislative matters**

Protecting America's Heartbeat is the theme for the NARFE campaign to fight back against the unprecedented attacks on federal workers' benefits and pay by some members of Congress and in the media. NARFE has engaged the services of M+R Strategic Services in this fight. NARFE HQ is putting into action plans to engage our members to inform their members of Congress about our legislative goals. NARFE magazine will have specific information in the months ahead for all members and GEMS messages are providing timely news to the 55,000 NARFE members who receive them. M+R Strategic Services was able to give specific information about the nature of the threat to the 275 NARFE leaders who attended the National Legislative Training Conference in the days following the NEB meeting. ### A Great March Program

Dr. Rusty Russell, Herbarium Manager, National Museum of Natural History, spoke at our March meeting with a strong advocacy for the significance of a historical event in U.S. history that has not been given the recognition it deserves — the U.S. Exploring Expedition of 1838-1842, also known as the Wilkes Expedition, in honor of its commanding officer. Dr. Russell’s presentation was both entertaining and educational. His slides contained a number of examples of the actual plants collected over the four years of the expedition, as well as correspondence and drawings from the expedition. He pointed out such little known facts as it was this expedition that is credited with the discovery that Antarctica is a continent.

### Bylaws Approved

The Executive Board spent over a year analyzing, discussing, debating, and revising the chapter bylaws to produce a less prescriptive document that has added flexibility in chapter operations. The revision was published in last month’s newsletter and copies were available at the March meeting. After presentation and discussion, the bylaws were approved unanimously by the members present.

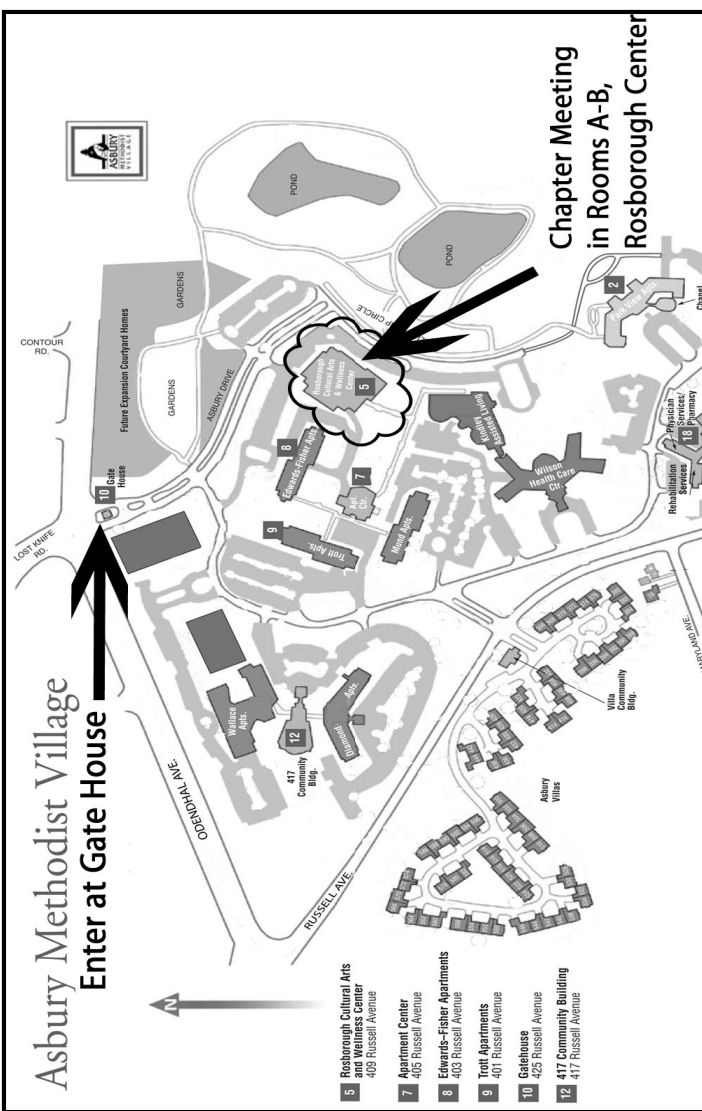
