# PRESIDENTS' MESSAGE – John Padan and Larry Lange

By the time this newsletter reaches you, the *primary election* will be over and we will know who will be running for office in November in Maryland. Dave Roseman, our Maryland Federation State Legislative Committee member and United Seniors of Maryland (USM) delegate, frequently advises us to get involved in the political process. He reminds us that if we do nothing to help the candidate of our choice we can't complain when he or she loses. How many of you have had experience *working as a volunteer during a state or national election campaign*? I, Co-President John Padan tried it and it turned out to be very rewarding and quite a bit of fun. Let me tell you about it.

I signed up to help our local state senator and a couple of our delegates during their campaign in 2010. I reasoned that if I helped out and let people know that I was a member of NARFE it might help our cause in Annapolis. In a nutshell, I walked around neighborhoods with a candidate or experienced volunteer participating in front door interviews, worked a phone bank, participated in a photo shoot, and drove voters to polls. I especially enjoyed a chance to get acquainted with our elected officials. Surprisingly, whatever I did was really appreciated and I was never under pressure to do more than I wanted to do. Volunteer for someone between now and election day and remember to mention NARFE!

If you are able to break away from campaigning for one week in August, we hope that many of you will consider serving as a delegate to the **NARFE National Convention**. Those trips are very informative as you participate in shaping the direction in which NARFE will move in the future. The Maryland delegation will have reserved seating but you will have opportunities to move around. Delegates will cast floor votes on many issues and will also participate with other delegates to reach agreement on how the chapter's votes will be cast in a secret ballot on other matters. One time I recall meeting in plenary session, then in a regional session, a federation session, and finally meeting as a chapter! Sounds dull but when you are at a convention it is fun. The convention will be held *in Reno from August 26 to August 30*. See your NARFE magazine for details.

# FEDERAL LEGISLATIVE REPORT

The onslaught on the federal community continues in the House budget proposed by House Budget Chairman Ryan. This includes a continuation of the current pay freeze for three more years for the federal civilian workforce, and a 10% reduction in federal civilian staff, over ten years, by replacing every three retirees with only one hire. These proposals are meant to contribute to reducing the deficit, but proposed cuts in taxes will overwhelmingly benefit the rich and make a mockery of NARFE's plea for shared sacrifice. Nevertheless, criticism of the budget is expected to come from some of Ryan's even more right wing colleagues, who do not think that it reduces the deficit fast enough and would favor deeper cuts that would impact even more on us.

The long standing parity in benefits between federal military and civilian employees was breached with the adoption of the two year pay freeze. This decision will be influenced by widespread sympathy for the troops in harm's way, but there are federal civilian employees in the same danger areas, and many military who are not. Yet the Ryan budget further impacts on the pay and benefits of federal civilians with no comparable changes proposed for the military.

The 10% across the board reduction in civilian staff will not discriminate between those agencies who run a tight ship and those where this contraction could be more readily absorbed. This is likely to result in poorer service, functions curtailed or eliminated which benefit segments of the population, and some substitution by private company activity at greater expense, because of reduced resources and greater difficulty in hiring quality staff.

The extent to which the current and future proposals which NARFE opposes are implemented will be greatly affected by the next election. Hence NARFE is identifying elections across the country where the result is expected to be close and intends to support candidates more favorably disposed towards NARFE's concerns than the opponent. The new MD 6 district is high on this priority list. If the fate of your benefits, and the survival of effective Federal roles, is high on your list of concerns,

- take an active interest in the election process, supporting the candidate of your choice.
- make a contribution to NARFE PAC where donations are used to support worthy candidates.

### **State Legislative and USM Report**

USM's March meeting considered revisions to their bylaws. The committee proposal to provide each individual member with the same voting rights as organizations such as AARP, NARFE and others, with NARFE leading the way was defeated. *MD Federation President Ted Jensen* was present. Individual members were given the vote in officer elections, and free admission to the annual legislative forum with dues paid. Also, NARFE and three other organizations were given a permanent seat on the board of directors where the bulk of the work is done. For more USM info go to their www.unitedseniors.net web-site.

# On the Legislative Front

By the time this Newsletter is received, the Maryland Legislative Session will have ended. The results of the session will include: raised taxes for all Maryland taxpayers; more regulation on citizens such as smoking in cars with children under eight years of age; more regulation on counties; more costs transferred to the counties (pension costs), higher utility bills if offshore wind energy passes, even if the federal money will probably not be available to make the project viable; health exchanges; a possible public works bill that would allow the executive branch to seek partnerships with private companies to privatize state facilities; and lastly a possible tax increase on the price of gas. Also, the primaries will have been completed and candidates for state congressional districts decided. If you were active and made your preferences known to your legislators and you voted in the primaries you have earned the right to celebrate or complain. If you didn't participate, just pay your taxes quietly. Everyone can learn more about the legislative session at our April 24th LEGISLATIVE FORUM. A number of legislators will be attending and will give us their view on the session. A lunch at 12:30 p.m. precedes the forum at 1:15 p.m. See p. 5 for coupon reservation and directions.

# GENERAL ASSEMBLY'S NARFE SUPPORTED BILLS

The General Assembly opened its 90-day session January 11. The \$1.0 billion deficit was expected to be a big issue. Governor Martin O'Malley proposed a FY 2013 budget with two major features and a host of lesser ones to address the deficit. To reduce expenditures he proposed to shift to the counties the cost of teacher pensions. His largest revenue raising proposal was to reduce exemptions and deductions for higher income taxpayers.

Members of MD NARFE's State Legislation Committee (MNSLC) testified on various bills heard by the House Ways and Means Committee and/or the Senate Budget and Taxation Committee (SB&T) that dealt with these proposals. In testimony they opposed the teacher pensions cost shift to the counties as it would not benefit Maryland taxpayers.

### They (MNSLC) supported bills:

- (1) requiring corporations to use combined reporting, which is required in 23 other states (HB 941),
- (2) expanding the sales tax base by including a wide range of services (HB 1051),
- (3) equalizing the special exemption for elderly taxpayers (HB 874),
- (4) establishing an annual tax credit for long-term care insurance (HB 347/SB 35),
- (5) including income from IRAs as part of the pension exclusion that can be claimed by elderly (age 65 and over) taxpayers (HB 1129/SB 847), and
- (6) establishing an orderly multi-year procedure to evaluate the many tax credits that Maryland provides (HB 764/SB 739).

At this writing (3/23) it appears that the tax credit evaluation bill is still alive after having been amended to delay action by one year and eliminate automatic termination of tax credits. The bill requiring combined reporting of income by corporations failed in SB&T by a 7-6 vote with the support of Committee Chair Kasemeyer, Vice-chair McFadden, and Sen. Robey, Democrats, and four Republican members.

The Senate and House of Delegates have passed quite different versions of the Budget Bill which will have been reconciled by the time this newsletter is published. **The General Assembly ends on Monday, April 9**<sup>th</sup>.

# **DUES WITHHOLDING FOR RETIREE MEMBERS**

Are you a retiree member of NARFE? If so, then think about electing to pay your membership dues by automatic small monthly deductions from your annuity payment. For members of this chapter, the amount of dues withholding is \$3.50 per month. By signing up for dues withholding you will save \$6.00 every year off your dues and you will never again write a NARFE dues check.

If you have ever received a dues notice, put it aside for later payment, and then several months later received a notice from NARFE headquarters that your membership is being terminated for non-payment of dues, then dues withholding is the way to go. With dues withholding, you will **never** have to be concerned about being dropped from the NARFE member rolls.

# NATIONAL CONVENTION RESOLUTION Dick Strombotne

At the February 28<sup>th</sup> chapter meeting the members present voted to submit the following resolution to the 2012 National Convention (NatCon):

"NARFE supports legislation to remove the increase in pension contributions of new federal employees enacted in February 2012."

In February 2012, Congress increased the pension contributions of new federal employees to 3.1% from 0.8%, effective in three steps starting in 2013. It is part of the *Middle Class Tax Relief and Job Creation Act of 2012*. This permanent penalty to new federal employees is used to pay for temporary changes to the Medicare "doc fix" and to extensions of unemployment insurance in 2012. There is no connection between the temporary changes and the permanent penalty on new federal employees.

This was the only resolution submitted to Maryland NARFE for consideration at the Mini-convention on April 30 - May 1, 2012. Assuming it is approved there, it will be published in the Resolutions book sent to chapter secretaries and all delegates by the end of June. The convention's Legislation Committee will then consider whether to include it as part of the NARFE Legislative Program for the 113<sup>th</sup> Congress. The 2012 NatCon delegates will have the final say.

New appointments by *President Joe Beaudoin* include *Evelyn Kirby*, MD NARFE's 1<sup>st</sup> Vice-president and Legislative Director, as Legislation Committee's Vice-chair, and *Marty Strombotne*, Secretary, to the convention's Ballot and Teller Committee.

# **GET INVOLVED IN THE POLITICAL** PROCESS TO PROTECT AMERICA'S **HEARTBEAT, OUR PAY AND BENEFITS**

The political season is in full swing; mailboxes are stuffed with candidate flyers for April 3<sup>rd's</sup> primary election, and Jim Cowie's article (p. 2) suggests ominous futures for us as different political philosophies vie for power. Outcomes clearly will be determined by November's general election.

What should you do to engage the process and Protect America's Heartbeat (PAH)?

Read the NARFE magazine. Professional legislative analysts provide facts, insights and opinions about federal policies and proposals that directly affect us. For example, the April issue summarizes the President's 2013 "budget savings at expense of feds." We can expect a report on the Republican "Ryan budget" in next month's publication.

Become informed of the issues and candidates' positions by reading news media, visiting candidate's web sites, participating in forums and asking questions about candidates' positions. Chapter 581 will sponsor a forum for State legislature representatives, and, in cooperation with other Chapters, will sponsor a forum for federal Congressional candidates.

Visit the NARFE HQ website (http://www.narfe.org/ departments/home/index.cfm) for up-to-date information on legislation and administration activities that affect employees and retirees. Also monitor the Protect America's Heartbeat website for legislative alerts and use the "quick send" message to Congressional representatives. Access PAH from NARFE HQ home page or go to http://www.narfe.org/heartbeat/; then just fill in sender information, click on "send my message," and a letter will go by e-mail to your representative, senator or an administration official. There is a new March 23 alert about "House majority budget targets federal workers with \$368 billion in cuts."

**Register with GEMS** (Global Email Messaging System). Go to https://www.narfe.org/updaterecord/update record.cfm and enter member ID# and DOB, and you will get NARFE HQ's vital weekly e-mail updates about federal activities; legislative alerts to use the "quick send" message to Congressional representatives and the President.

**Express your views to Congressional and Administration** leaders. It is easy if you use the Protect America's Heartbeat website. If you do not use the internet, express your views by personal letter or phone call.

Support candidates of your choice in both primary and general elections. Volunteer or offer funding for candidates' campaigns; contribute to NARFE PACs at state and federal levels, which support candidates whose philosophies (views) are aligned with NARFE's interests. (Continued on right column)
