## CONVENTION MARKS 55th ANNIVERSARY OF NARFE'S MD FEDERATION

The Maryland State Federation of the National Active and Retired Federal Employees Association concluded its 55<sup>th</sup> anniversary celebration recently in Bowie with over 200 delegates in attendance representing approximately 21,000 members from 34 chapters throughout the state.

Commenting on proposals on Capitol Hill to reduce the federal workforce, guest speaker for the two-day convention, John Gage, National President of the American Federation of Government Employees (AFGE), described the recent House budget plan as an “ideological attack that we cannot tolerate” and that “federal employees were not the cause of this deficit.” Adding that “millions of jobs are now on the chopping block” and that the recommendations of the President’s Debt Commission were “horrifying,” Gage concluded that he was “not happy with either side” of the political aisle.

During the convention, hosted by the Greater Bowie/Crofton Chapter and held at the Bowie Comfort Inn, delegates also heard from Paul Carew, NARFE National Vice President. Carew stated that “NARFE is fighting back” through the *Protect America’s Heartbeat* campaign launched recently by the 300,000+ member organization. Explaining that the federal workforce was less than two percent of the budget calling it “low hanging fruit” (meaning the first to be picked) in terms of the proposed budget cuts, Carew said “We don’t mind being part of the solution but not all of the solution.”

The convention agenda also included election of the following officers to serve the Maryland Federation for the next two years: Ted Jensen (Frederick), President; Evelyn Kirby (Chester), 1<sup>st</sup> Vice President; Barry Grier (St. Leonard), 2<sup>nd</sup> Vice President; Jeanette Green (Waldorf), Secretary and Dick Strombotne (Gaithersburg), Treasurer.

Headquartered in Washington, D.C., NARFE recently celebrated its 90<sup>th</sup> anniversary, founded by 14 federal workers in 1921. The organization focuses on “safeguarding and improving the earned rights and benefits of active and retired federal employees, representing over five million federal workers, retirees, spouses and their survivors.” The latest government data indicates Maryland has 282,500 active and retired federal employees.

## PRESIDENT'S MESSAGE...

The focus of this special edition is two-fold - to provide highlights from the Maryland State Convention and further information on NARFE's national campaign to fight drastic cuts in federal pay and benefits whose slogan is “Protect America’s Heartbeat.” (See page 3.) While issues regarding the ongoing budget debate will be discussed in the NARFE magazine, the most up-to-date source for what's happening that we need to be aware of is through GEMS. If you haven't signed up, please do so, especially if you are an active federal employee.

The Maryland State Convention was held on May 2-3 in the

Bowie Comfort Inn and some of the highlights are contained in the press release by VP Barry Grier above. The two-day format worked well - there was only one resolution considered and the election was not contested. Attendance was up from the 2009 convention with our chapter having the second largest delegation, behind that of the host chapter Greater Bowie/Crofton. President Ted Jensen summarized our status well as observed through the convention activities, saying we have a good organization, and doing good things for others as well as ourselves.

The keynote was provided by Paul Carew, National Vice President. He clearly recognizes that the future of NARFE will depend on its ability to adapt and change with the changing environment. Among other things, he noted an ongoing activity to update head-quarter's use of information technology to better utilize current tools.

The convention wasn't all work. At the end of each day door prizes provided were awarded. Three of our delegates were lucky enough to have their names drawn.

**FEDERAL LEGISLATIVE REPORT**

There has never been a time in living memory when the Federal Community has been under such a sustained attack as has happened recently in Congress. The two-year freeze on federal salaries was the first step by a mind-set that does not appear to understand the contributions that are made by the Federal Community. A proposal to halt any step increases and merit awards in two years was defeated, but undaunted, this has reappeared in a proposal to extend the freeze time frame to five years. Other elements under consideration include calculating an annuity on the basis of the high five years of salaries rather than the current high three, changing the formula for the definition of COLAs to reduce the amount of an increase, eliminating the defined benefit component of FERS salaries (the Thrift Savings Plan elements and Social Security contributions would remain; if this happened we would need to redefine our rules for eligibility to join NARFE since future FERS employees would not qualify under the existing rules), and increased contributions to health coverage and pension payments.

These incessant attacks on the Federal Community seem to be based on an ideology which does not appear to understand the factors that have contributed to the rising deficit, including two wars, an unfunded Prescription Drug benefit, greater emphasis on Homeland Security, an increasing population and steps that needed to be taken to respond to the recession and recent disasters such as Katrina and the Gulf Oil Disaster. The current budget proposals by the President and the Republican alternative will both increase the deficit for many years to come by 7 trillion dollars or more. Hence, if reducing the deficit is a primary objective, then all the elements that contribute need to be addressed, and the heavy concentration on the discretionary budget, which determines the contribution made by the Federal Sector needs to stop, since this amounts to only about 15% of the total. NARFE might also need to consider whether it should continue to concentrate on protesting every proposal that affects us negatively, or whether it should also promote ideas of what the overall deficit reduction strategy should include that NARFE would consider to be fair to all parties, rather than our being asked to shoulder a disproportionate share of the pain.

If the attacks on the Federal community continue and more elements are implemented, the most likely outcomes will be that more staff will leave before the damaging changes are implemented than the service can afford to maintain quality, and potential recruits will respond to the apparent low regard for public service by taking their skills elsewhere.

**STATE LEGISLATIVE REPORT**

While the State Legislative session for this year has ended, this does not end the political activity in the State. Now that the session is over the State Legislators are allowed to raise funds for future campaigns. Many of our delegates and senators are having fund-raising and other events to report on their activities for the past session. The State Legislative Committee has received numerous requests for funds from MD-PAC based upon responses from the local chapters making contributions and attending these events. In addition, many trial balloons are being sent up with respect to an upcoming special session of the legislature. Every ten years after the census is completed the State legislature gets to review legislative boundaries in special session. Governor O'Malley has proposed several possible items to be addressed in this special session including a transportation tax or a raise in the sales tax. During the coming months these and any number of issues will be brought up and suggested for the special session. All of you need to carefully follow this in your local papers and use every opportunity to talk to your legislators and make your points.

At the same time do not forget that the Montgomery County Council and our County Executive are still fighting and posturing over a county budget. The only thing we can be sure of is less services and higher fees and taxes. Again we must be vigilant and make our feelings known.

Lastly, the State Legislative Committee is working on an overall framework for presenting our case to our legislators and the Governor. We are working on framing the benefits to the State that derive from seniors living in the state such as volunteer time, spending of discretionary income and minimal need of expensive state and local services such as schools. Most of the brunt of the proposed changes would be felt by current and future Federal staff, with health contributions being the primary area of concern for existing retirees.

**PROTECT AMERICA'S HEARTBEAT**

**America's federal employees protect this country's heartbeat**

"Federal employees ensure our food is safe and our air is healthy, among many other important functions. Some spend their days fighting the spread of infectious disease, while others raise the alarm whenever a storm is coming." (from the NARFE Protect America's Heartbeat web page). We need to preserve the collective **heartbeat** of the federal workforce that protects us and drives America's progress, while keeping the values that attract and retain the best American workers.

**What can Chapter members do to communicate our role in protecting America's heartbeat?** As an active or retired federal employee who dedicated your life to protecting America's heartbeat, share your story by telling:

At HQ, Julie Tagen and a contractor will be communicating the stories to legislative interests and media outlets. We also have other suggestions for use and communication of the stories by the Chapter.
