A VOYAGE OF DISCOVERY FOR A YOUNG NATION

What do you know about the United States South Seas Exploring Expedition of 1838-1842? Did you know that it was one of the largest voyages of discovery in the history of western exploration and that the thousands of specimens and artifacts collected by its scientists formed the foundation for the collections of the Smithsonian Institution? Rusty Russell, Herbarium Manager at the National Museum of Natural History, will be with us in March at our next meeting to discuss this expedition from the perspective of a botanist.

PRESIDENT'S MESSAGE... *Mary Anne Scott*

NARFE is facing a two-edged sword. One side presents serious threats to our earned benefits. A declining membership with the accompanying loss in effectiveness to defend against those threats is the other side. At the Maryland Federation Board meeting in February, we heard encouraging reports that our new leaders in NARFE Headquarters are strategizing and making progress in dealing with these problems. The slogan "Protect America's Heartbeat" is one element that will be used to frame the campaign to guard our benefits and counter misperceptions of federal workers.

What should you do? There are several things. If you haven't signed up for GEMS to get latest news, you should do so, then react to that news appropriately. (See www.mdnarfe.org for instructions.) Encourage your co-workers to join NARFE. Attend chapter meetings. Volunteer to help our chapter in some capacity. The Nominating Committee is working to select a slate of new officers (see page 3). You may not want to be an officer, but they will also be discussing other non-elective positions that contribute to the operations of the chapter.

Another opportunity is coming up soon. **Join us and attend the Maryland Federation Convention in early May.** It's close this time — in Bowie at the Comfort Inn and Convention Center — a great opportunity to make it a day trip if you don't want to stay overnight at the hotel and attend the full convention. The chapter will reimburse you for cost of registration and banquet, if you chose to attend. We'll be hearing from a Headquarters representative on how we're doing on the challenge of keeping NARFE strong and how well the strategies for dealing with threats are working. It will be an excellent opportunity to meet members from other parts of the state, share information, and to have a good time as well. Involvement in NARFE activities can be very rewarding — you meet new people, you hear other viewpoints on issues, and you help keep the organization strong. FEDERAL LEGISLATIVE REPORT

Cuts in the Federal budget of \$61 billion for the remainder of the fiscal year were passed in the House (these cuts would have been \$100 billion if they had been applied to the full year), but will not be acceptable in the Senate or by the White House. Yet the House has some leverage because approved federal funds will soon run out and the debt ceiling reached. The House may not agree to corrective action without major cuts.

NARFE is concerned that some politicians and active members of the general public have succumbed to propaganda which paints the Federal Community in very unfavorable terms which are neither accurate nor fair. In addition, it appears that many of the general public have little or no understanding of the federal contributions that citizens depend on. This lack of understanding and misinformation of federal roles have helped motivate the extreme proposals that have been approved in the House.

The NARFE magazine (March 2011, p.38) reports on a campaign to try to counter these threats. (See www.ProtectAmericasHeartbeat.org.) This has two goals — to counter the misinformation about federal employees, and to explain the many contributions we make to the functioning and safety of America. NARFE has commissioned this activity with an external firm (M & R) so that it is promoted at arm's length from NARFE and to make it easier for it to be supported by other organizations which share our objectives.

As a result of the campaign, it is expected that more Representatives and citizens, who are more willing to be open minded about the contributions of the Federal Community, will become more sympathetic to our concerns and may oppose us being treated unfairly. However, active support for our cause is more likely to happen where a citizen faces losses from the overreach of the proposed cuts, for example, from reductions in Head Start or less opportunity to fund family members in college. If enough people object, it may become clear that the House claim that they had a mandate, to impose cuts to the extent of \$100 billion, did not in fact have the support of a clear majority of the electorate, any more than their claim of having a mandate to repeal health legislation, when polls say that public approval was evenly balanced.

STATE LEGISLATIVE REPORT

The State Legislature has been in session since mid-January and is moving at a relatively slow pace with respect to issues of concern to us as members of NARFE and as citizens concerned with the huge budget deficit. *The Washington Post* wrote on Monday February 21st that "O'Malley's legislative agenda - which friends and foes say appears geared toward burnishing his fiscal and environmental credentials for possible national ambitions - is drawing heavy criticism from unions as well as lawmakers in both parties." There are now bills to increase taxes on everything from alcohol to gasoline, as well as bills to shift or revise the formulas for sharing state revenue with the counties. Additionally there are bills dealing with social issues such as same-sex marriage, legalization of medical marijuana and in-state tuition breaks to undocumented immigrants.

Bills of specific interest to NARFE include Income Tax Credit for Long Term Care Insurance premiums, HB 562 and SB 618 and 703 with a senate hearing on 3/11 at 1PM in the Senate and Budget and Tax Committee; Corporate Income Tax Combined Reporting, SB 305 and HB 731 with a hearing on 3/10 at 1PM in the House Ways and Means Committee.

You as good citizens and members of the community need to let your delegates know how you feel about what is going on in Annapolis. Please call, write, or e-mail all of your representatives and ask them to support the bills of your choice. You can follow the action on the bills by reading the Metro Section of *The Washington Post* or going to the Maryland website (<http://mlis.state.md.us/>). **REMEMBER, IF YOU DON'T TELL YOUR STATE REPRESENTATIVES HOW YOU WANT THEM TO VOTE, YOU CAN'T COMPLAIN WHEN THEY TAKE A POSITION CONTRARY TO YOURS. NOW IS THE TIME TO BE AN ACTIVE CITIZEN.**

PROPOSED REVISION TO CHAPTER BYLAWS TO BE VOTED ON AT THE MARCH CHAPTER MEETING

John Padan, former Chapter 581 President

Your Executive Board has spent the past year analyzing, discussing, debating, and revising the chapter bylaws. The resultant document is included on pages 4 and 5 of this Newsletter to prepare our members for a vote at the March chapter meeting. Usually, only a small section of the bylaws is proposed for review and both an edited and a clean version of the copy are included. This proposal involves too lengthy a document to allow two versions to be included in the newsletter. Only the clean copy, for ease of reading, is provided on the next pages. An edited version, either hardcopy or via email, may be obtained by contacting Larry Lange or John Padan (see back page of newsletter).

There were several reasons for this extensive review. One was the desire to be less prescriptive and to add flexibility to chapter operations (for example, not defining precisely when and what time the chapter is to meet). Another change was the clarification that VPs’ duties are to assist the president and not necessarily serve as legislative or membership officers (although those roles are required, as is the newsletter). The maintenance of a membership database has been dropped, as we are now better served by HQ in this digital age. Associate and Social memberships have been defined. Additionally, we have formalized the relationship with the Maryland Federation, agreed upon the use of *Roberts Rules of Order*, and have added a mechanism for voting by mail.

Gaithersburg NARFE--Chapter 581 Bylaws

Article I. Meetings of the Chapter

Sec. 1: The chapter shall meet monthly at a time and place determined by the Board and approved by Chapter members. The Chapter will not meet in the months of July and August. There will be a picnic meeting in June and a holiday party in December.

Sec. 2: Special meetings shall be called by the Chapter President when necessary, or upon written request of 15 of the Chapter's voting members. Written notice of all special meetings shall be given to each chapter voting member at least seven days before such meeting.

Sec. 3: A quorum for conducting chapter business, at either a regularly scheduled or special meeting, shall consist of 15 of the chapter's voting members. Less than a quorum may adjourn to meet on a future date, of which due notice shall be given to each voting member.

Article II. Order of Business

The following shall be the order of business at all regular meetings of the Chapter, except that the President may make adjustments as needed at any given meeting:

1. Call to Order
2. Non-denominational invocation (or moment of silence)
3. Pledge of Allegiance
4. Introduction of New Members and Guests
5. Reading of or reference to the minutes of the preceding meeting (posted before the beginning of the current meeting)
6. Reading of Communications
7. Reports of Officers
8. Reports of Committees as requested by the President
9. Unfinished Business
10. New Business
11. Announcements
12. Program
13. 50/50 Drawing
14. Adjournment

Article III. Officers and Committees

Sec. 1: The elected officers of the Chapter shall consist of a President, First Vice President, Second Vice President, Secretary, Treasurer, Financial Secretary, and such other officers as the Chapter may elect.

Sec. 2: The President shall preside over all Executive Board and regular meetings; shall enforce observance of the By-Laws; shall appoint Committee Chairpersons; and shall be an ex-officio member of all committees with the exception of the Nominating Committee.

Sec. 3: The First Vice President shall assume such duties as assigned by the President and, when called upon, assist the President and in his/her absence shall perform his/her duties. He/she shall immediately succeed to the Presidency in case of vacancy in that office.

Sec. 4: The Second Vice President shall assume such duties as assigned by the President and, when called upon, assist the President and shall automatically succeed to the position of First Vice President in case of a vacancy in that office.

Sec. 5: The Secretary shall keep a record of the proceedings of each Executive Board meeting and of each Chapter meeting. Detailed minutes of each meeting shall be prepared and read or posted at the next Chapter meeting.

Sec. 6: The Treasurer shall: (a) be custodian of monies belonging to the Chapter; (b) be responsible for depositing these funds in any federally insured financial institution in the name of NARFE Gaithersburg Chapter No. 581; (c) upon request, give receipts for all funds received and pay by check all valid debts incurred by the Executive Board or by action of the Chapter; (d) be responsible for keeping an accurate record and itemized account of all receipts and disbursements; (e) make a brief report at each meeting; (f) submit to the President, in July, a report summarizing all financial transactions since the preceding annual report of the Treasurer; (g) upon the close of one fiscal year, prepare a budget for the next fiscal year in consultation with the President – the fiscal year shall be from July 1 to the following June 30 – the budget shall be subject to approval first by the Executive Board and then, by September 30, the general membership – the budget shall be used for guidance throughout the year – the Treasurer's annual report shall include a direct comparison with the budget approved for that year; and (h) ensure filing of tax reports required by the IRS.

Sec. 7: In July, at the start of the chapter's fiscal year, the financial records shall be submitted by the Treasurer to the Auditing Committee or to the Auditor appointed by the President. A report of the Auditing Committee or Auditor shall be made at the September Executive Board and Chapter meetings. In the event a Treasurer does not complete his or her term of office, an audit will be conducted promptly and a report presented to the Executive Board within two months and to the Chapter at its next meeting following that Board meeting.

Sec. 8: The Financial Secretary is responsible for Chapter 581 Life Memberships, including receiving Life Membership payments, recording them, notifying the Chapter Membership Chair for forwarding to National, and providing information and forwarding payments to the Treasurer for adding to the Chapter Life Membership account.

Sec. 9: A Membership officer shall be appointed by the President. The duty of the membership officer shall be to develop and carry out a membership plan that describes organized efforts to gain and keep members, encourage dues withholding, and contact lapsed members. A further duty shall be the maintenance of the Chapter's membership database.

Sec. 10: Legislative officers shall be appointed by the President to: (a) keep abreast of state and national legislative matters concerning federal civil annuitants and prospective annuitants; and (b) make recommendations for action to the Chapter, the Federation, and the Association.

Sec. 11: There shall be an Executive Board consisting of all elected Chapter officers, past presidents, committee chairpersons and such other persons as the President may appoint and who are approved by the Executive Board. Appointment and approval shall be noted in the applicable Board meeting minutes. The Executive Board shall meet monthly (except in the months of June, July, August, and December) when called by the President.

The meetings shall be open to any Chapter members, but only Executive Board members shall have a vote. There shall be a planning meeting of the Executive Board every August.

Article IV. Election of Officers

Sec.1: The President shall appoint a Nominating Committee in November prior to an election year. The Nominating Committee Report shall be made at the April Board and Chapter meetings.

Sec.2: Following the report of the Nominating Committee, the President shall ask for additional nominations for any elective office from the Executive Board as well as from the general membership during the April and May meetings. Along with such nominations it must be stated that the nominees have given assurance that they will serve if elected.

Sec.3: Chapter officers shall be elected by a simple majority vote of the Chapter members present at the May meeting. Each member shall have one vote.

Sec.4: Each elected officer shall normally serve a term of two years or until a successor is elected and installed. However, an officer may be replaced for cause after due process by the Executive Board. The term of office shall be from July 1 to June 30. In the event that any officer is absent for three or more consecutive meetings without a valid reason, such officer may be asked to resign.

Sec.5: Elections will be held in odd-numbered years to ensure that the new officers have at least one year's experience before being asked to represent the Chapter at a National Convention, which is traditionally convened in even-numbered years.

Sec.6: If a vacancy occurs at any time in any elective office, the Executive Board shall select a member to fill the vacancy for the unexpired term.

Sec.7: Delegates to NARFE conventions shall be elected at regular meetings of the Chapter at least four months (National) and two months (State) prior to the convention.

Article V. Dues

Sec.1: Lifetime memberships may be purchased in accordance with rate structures established from time to time by a vote of at least 2/3 of the members present at any regular meeting, following due notice having been provided in accordance with Article VII of the Chapter Constitution.

Sec.2: Lifetime memberships shall not be refundable, transferable to another member, or transferable to another chapter. A lifetime member shall become a lifetime associate member upon obtaining primary membership in another chapter. A lifetime member who drops National membership shall lose Chapter membership privileges until National membership is restored.

Sec.3: Annual dues for Associate and Social members, who are members of another NARFE chapter, shall be due each January 1. NARFE members who affiliate with any Chapter other than their "Home Chapter" shall be designated as "Associate Members." Associate Members shall pay Chapter dues and may hold office within the chapter but cannot be included in the total Chapter membership count for determining representation at National Conventions. Interested persons, other than spouses, not receiving annuities from civilian service, who belong to the immediate household of a Chapter member, may be enrolled as

Social Members of the Chapter upon payment of such Chapter dues as the Chapter Bylaws may prescribe, but without payment of National dues. A Social Member may not hold office nor have a vote except as to social events of purely local concern.

Sec.4: The dues for Chapter membership will be set in accordance with rate structures established from time to time by a vote of at least 2/3 of the members present at any regular meeting, following due notice having been provided in accordance with Article VII of the Chapter Constitution.

Sec.5: Any chapter document relating to dues or contributions must contain this statement: "Dues payments and gifts or contributions to NARFE are not deductible as charitable contributions for federal income tax purposes."

Article VI. Financial Authorities

The Board would seek the approval of the membership, by means of a vote at a regular meeting of the general membership, before incurring expenditures whenever the budget approved, per Article III Section 6(g), is exceeded by \$2,000 or more with respect to any one item in the budget, an unanticipated item, or an accumulation of expenses.

Article VII. Affiliation with State Federation

This chapter shall be affiliated with the Maryland State Federation of Chapters, subject to the constitution and bylaws of that body.

Article VIII. Parliamentary Authority

The provisions of *Robert's Rules of Order, Newly Revised* shall govern chapter business in all matters not in conflict with the Chapter Constitution and Bylaws or the Association's Articles of Incorporation and National Bylaws.

Article IX. Voting by Mail

Sec.1: Although *Roberts Rules of Order, Newly Revised* discourages voting by mail, preferring instead for parliamentary bodies to focus on the direct exchange of ideas, there may be occasions when an Executive Board wishes to solicit the opinion of a wider segment of the chapter membership than those commonly in attendance at chapter meetings. This article provides that authority.

Sec.2: Issues of concern shall be brought to the members' attention by means of the Chapter newsletter.

Sec.3: If formal feedback is necessary, a ballot shall be included in the newsletter in such a manner that it identifies the member.

Article X. Newsletter

Sec.1: A newsletter shall be prepared and sent to each Chapter member for each of the months in which a Chapter meeting is held. The schedule shall be determined by the Executive Board.

Sec.2: The newsletter shall include reports of recent Board meeting decisions and actions taken at the previous Chapter meeting, as well as other timely news and information.

Article XI. Amendments

Amendments to these By-Laws may be enacted by concurrence of two-thirds of the members present at any regular meeting, provided due notice has been given in accordance with Article VII(b) of the Chapter Constitution.

The basic details of the MD Federation Convention were offered in our February newsletter. This is a crucial period for Federal employees and annuitants and others in the public service sector. Come to this two-day convention in Bowie and hear top speakers, such as NARFE's VP Paul Carew, bring you up to date on NARFE's efforts to prevent us from being forgotten. We will also hear from John Gage, President of AFGE, on Tuesday. As noted last month, we don't plan all work. There'll be door prizes each day and the 50-50 will be split between two ticket-holding attendees. We'll have some fun with a reception and banquet with a live band. If you go as a delegate for this chapter, your registration and banquet costs will be reimbursed. FEDERATION NEWS: MEMBERSHIP RETENTION

The Maryland Federation of Chapters (Maryland NARFE) has undertaken three activities to increase membership retention. In November, Maryland NARFE sent 473 personalized letters to a group of lapsed Members. It informed them that they could save money by rejoining before January 1, 2011, when the new dues increase would take effect. By the end of January, 35 of these lapsed members had rejoined for a total of 60 membership years.

Early in February, Maryland NARFE put its new Dues Withholding Incentive Program (DWIP) into effect with the first of a series of monthly mailings to groups of recent members whose memberships are about to expire. The personalized letters offer recipients a rebate of \$5.00 if they sign up for dues withholding when they rejoin. The rebate is in addition to the 15 percent discount they receive on national dues by going on dues withholding. With dues withholding, Gaithersburg chapter members pay just \$3.50 per month to cover annual chapter dues of \$8.00 and discounted national dues of \$34.00. Members can sign up for dues withholding at any time by using the form in NARFE magazine (January issue, page 49) or from the NARFE web site, www.narfe.org. It will go into effect at the end of their current membership term. Once they have signed up they will never again receive a dues notice.

Also in February, Maryland NARFE started sending personalized letters to lapsed members whose membership expired about nine months earlier. These letters invited them to rejoin and provided application forms for reinstatement and for dues withholding. Similar letters to lapsed members will go out each month in a pilot program to see how effective the approach is. President Mary Anne Scott sent some 20 letters to lapsed members of Gaithersburg Chapter 581.

NARFE has a long-standing policy requiring lapsed members to come back as **new members** if they rejoin more than one year after their membership has expired. It is hard to see now how that policy fosters retention. Consequently, Membership Retention Committee Chairman Dick Strombotne is seeking the end of this policy. The arbitrary one-year limitation hinders NARFE's efforts to retain members and grow in numbers. Currently NARFE has no continuing program in place to get lapsed members to rejoin after their membership has been expired for more than six months.

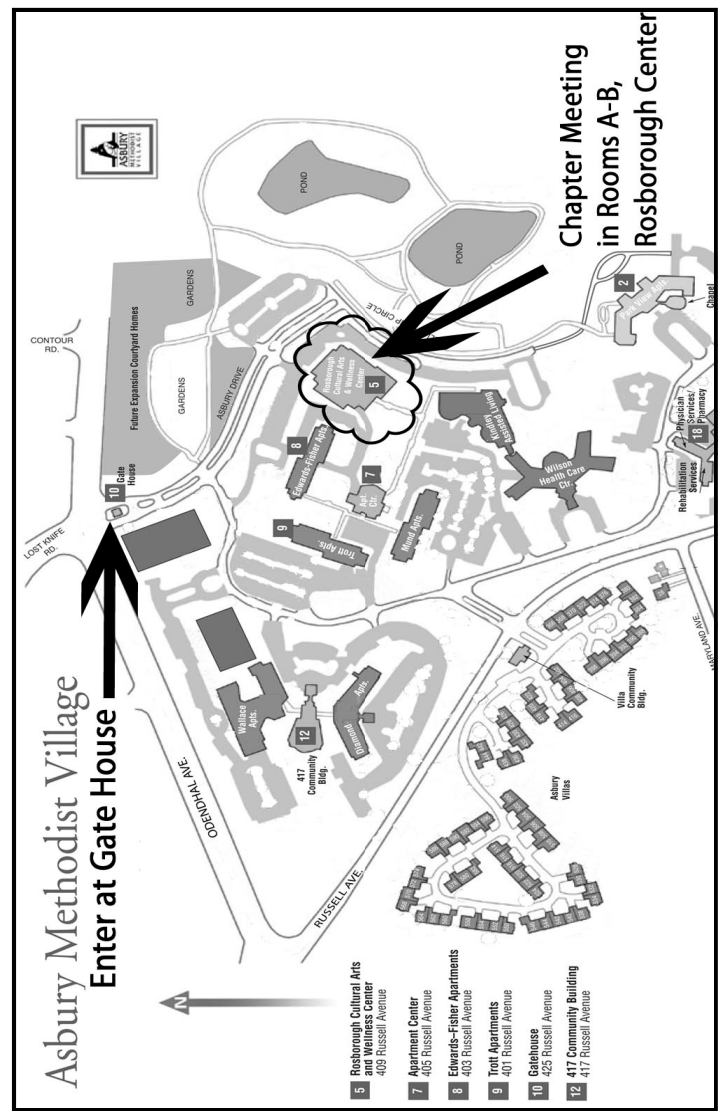


Remember, when the Montgomery County schools are late opening or closed, NARFE Chapter 581 scheduled meetings or events will not be held.
