## STATE LEGISLATIVE REPORT

The State Legislative Committee (SLC) and MD-PAC have been busy this summer laying the ground work for the upcoming legislative session. Your SLC has been working in a variety of ways to represent NARFE with our state representatives. They have worked with the United Seniors of Maryland (USM) and sent a joint letter to the Governor pointing out that his list of priorities failed to include seniors. As a result, a joint meeting was held with NARFE and USM with some of the Governor's staff. At that meeting your SLC was able to make our case. We believe given the poor budget outlook that our best hope for immediate success lies in the Long Term Care issue - providing annual tax credits to individuals who purchase long term care insurance. We are also again working with Delegate Jim Gilchrist to submit legislation to equalize the tax exemption for seniors and blind taxpayers. We hope to structure the bill so that there is no budget impact for the upcoming year. By delaying the budget impact we may be successful. MD-PAC has been collecting donations and while collections have slowed down over the summer, we hope all of you are prepared to start donating this fall. We have recently attended events for Delegate Resnick and Tony O'Donnell. Both of these events provided us with great opportunities to make our case.

The upcoming session is not going to be pretty since the budget outlook is very grim. The shortfall could be estimated as high as \$1.5 billion. To support our agenda and to especially ensure that we don't lose any of the benefits or services we currently enjoy, we are going to need the grass roots support of you our members to write and call our delegates and to provide financial support to the PAC. Remember donations to the MD-PAC can be sent to MD-PAC, 6 Thorburn Road, Gaithersburg, MD 20878. An insert in this month's newsletter gives you information on how to contact your state representatives. All of us working together can make a difference.

### FEDERAL LEGISLATIVE REPORT

The NARFE Legislative Department has issued a nine page document entitled "NARFE's Position on Comprehensive Health Reform and a Summary of Provisions Relevant to Federal Workers and Annuitants."

The situation in the House and Senate is extremely fluid and close monitoring is needed of the draft bills as they evolve to their final form.

The topics raised in the NARFE document (and our position on them) include: Premium Conversion; Opening the FEHBP to non-Federal civilians, (support only if they form a separate risk pool); Taxing Workers and Retirees for the value of Employer-Sponsored Health Insurance (Against); Coverage for Temporary and Seasonal Federal Workers (Support); Providing "Affordability Credits" to lower income Workers and Retirees (Support); Coverage for Dependent Children up to age 26 (Support); Expanding Medicaid eligibility (Support); Effect of Health Care Reform on Employers and Carriers (Concern about the impact on FEHBP); Ending the Medicare Part D Prescription Drug Cost Sharing "Donut hole" (Support); and Slowing the Growth of Medicare and Medicaid Provider Reimbursements (Concern about existing Providers withdrawing from these Programs).

This abbreviated Report does not do justice to the full document. # OPINION - UNIFIED DUES RESOLUTION - PRO

(Exerpts from An Open Letter to NARFE Members published June 2009 in NARFE)

... The purpose of a unified NARFE Dues is to aid in the recruitment and retention of members. In addition, it will benefit all chapters in maintaining their financial records by reducing the current number of dues categories.

The referendum proposes \$40 as NARFE Dues. Some members have asked me how we arrived at that figure. It comes from current National dues of \$29; average chapter dues of \$8.10; and 10 percent, or \$2.90, to the federations. If the referendum passes, it will cost each member \$40 (or \$3.33 a month): \$9 rebated to the chapters, \$4 rebated to the federations and \$27 for National Headquarters. The last thing we want to do is impose a financial hardship on members. We have some members who are living on a very small annuity. But without a strong, viable NARFE to fight to protect that member's annuity and health care benefits, the alternative would be much worse: a reduction of that annuity and benefits.

It's my opinion, and one I hope most of you will share, that \$3.33 a month is a bargain for what you receive as a NARFE member. It gives you the security of our legislative staff looking out for your interests on Capitol Hill, and seeing that you get all the alerts and information we can share with you. It buys each member a monthly magazine full of useful information on your benefits and what is going on that affects you. In addition, it gives you the work of our Retirement Benefits Service Department staff, who will help you with any problems you may have with your annuity and health care benefits. In fact, the department is your "Personnel Office" after retirement. And don't forget, a portion of your dues goes to chapters and federations to strengthen the work that they do for you and for NARFE.

The establishment of NARFE Dues will impact the majority of the membership. Your dues may change. Let me make this very clear. This is not an attempt to usurp the chapters' ability to raise the money they

# OPINION - UNIFIED DUES RESOLUTION - CON

Dick Strombotne, Immediate Past President, MD Federation

There are so many things that are wrong about the National Executive Board's unified dues resolution that it hard to list them all.

Reduces membership retention. One of NARFE's priorities is to increase membership retention. The resolution has the opposite effect for several reasons. The resolution increases total dues for most members of NARFE who are members of chapters and for many who are not chapter members. Strike one. By eliminating the 2-year and 3-year memberships with their discounts, it reduces the incentive for members to continue their membership in NARFE. Moreover, it takes away the NEB's authority to re-establish multi-year membership incentive programs. Strike two. The resolution reduces the incentive for chapters to promote dues withholding because the chapter would receive less revenue from members on dues withholding (\$8.00) than from other chapter members (\$9.00). Strike three.

Chapters and federations have the Unnecessary. power to increase dues and per capita payments to the level needed to conduct business. The increased revenues from the dues increase will be distributed to chapters and federations that don't need them. Moreover, the resolution eliminates the power of individual chapters to increase their dues in the future to meet rising costs except through the convention resolution process. Resolutions to establish unified dues have been considered in recent conventions and have failed to receive the necessary two-thirds of ballot votes cast. Most recently the issue was considered less than a year ago at the national convention in Louisville where it was defeated.

<u>Poorly drafted</u>. The resolution has substantial defects in its language. It removes the definition of "Honorary Members." It puts into the Standing Rules provisions that should be in the Bylaws. It fails to specify that Life Members who have paid chapter Life Memberships or for whom the chapter has waived dues shall pay no further fees. It fails to

need to keep the chapter in operation. All it does is standardize what nearly every member pays on an annual basis and prevent any nasty surprises to new members when they renew. It's a matter of keeping the members we have, as well as making it easier to recruit new members, because now you can tell them exactly what their dues will be for the first year, the second year and beyond.

specify in the Bylaws that the annual dues of Members-at-Large is \$29. It fails to deal with implementation issues, including a proviso for the effective date for Unified Dues and the issuance of national current life membership with the current fee structure. In general, it does not pass parliamentary muster.

Improperly placed before the members. The NEB has been careless in presenting the resolution to NARFE members. First, there is no record that the resolution in its current form was approved by the NEB members by the necessary two-thirds vote. Although few, if any, chapters have provisions for a mail-in vote, the NEB has provided a ballot coupon in NARFE magazine with the suggestion that it be sent to the president of the member's chapter. Such loose voting procedures are invitations for abuse.
