# **President's Corner**

Federal retirees, employees, and Social Security recipients WILL NOT receive a cost-of-living increase (COLA) in 2016. The following request was reported in the NARFE News Watch: NARFE is asking that members contact their Senators and Representatives asking them to support Senate Bill S. 2148, Protecting Medicare Beneficiaries Act of 2015, and House Bill H.R. 3696, Medicare Premium Fairness Act of 2015. The two bills would keep Part B premiums at their current rate (\$104.90 per month for most) for all Medicare beneficiaries in 2016. For federal retirees covered by the Civil Service Retirement System (CSRS) and who do not receive Social Security benefits, your Medicare Part B premium payment is slated to increase by 52 percent in 2016 (going from \$104.90 to \$159.30 per month). These two bills, filed by Senator Ron Wyden (D. OR), and Representative Dina Titus (D. NV), need co-sponsors to protect millions of seniors, including CSRS retirees, from the disproportionate increase in the Medicare Part B premium.

For those who missed the October chapter meeting, our guest speaker was Jim Resnick, Manager of the Montgomery County Fire and Rescue Senior Outreach Office, who discussed a variety of safety issues. Some of those issues included an evacuation plan, a determined-upon meeting place when a fire occurs once all family members are safely outside, and smoke detector locations. Mr. Resnick advised us that beginning in January 2018, one will no longer be able to use smoke detectors with a 9-volt battery as the primary power source; these will only be allowed as a backup power source. Mr. Resnick advised we should consider purchasing smoke detectors that have the 10-year batteries. Jim talked about being observant of your surroundings when entering public places, *i.e.* restaurants, offices, and stores and to note the exit locations (doors and windows) in case of fire. Mr. Resnick provided copies of the "Personal Planning for Emergencies" document and spoke about the benefits of keeping it up-to-date. The document includes space to list medical conditions, medications, health insurance, doctors' names and telephone numbers, and emergency contacts. This document should be maintained in the File of Life packet (which has a magnetic strip) and kept in a very visible place in your home (such as on your refrigerator's door).

November is the month that federal employees and retirees consider their choices in health insurance. Our November meeting will be on health insurance changes. It is scheduled for November 13th, at the Mykonos Grill, and our guest speaker will be Jennifer Malave. Jennifer has worked for CareFirst Blue Cross Blue Shield (BCBS) for 26 years. She started with BCBS as a customer service representative where she learned the benefits "like the back of my hand." Over the years Jennifer has held various positions at CareFirst, ultimately accepting a position as Marketing Representative for Care First BCBS, a position she has had for 16 years. Her team recently took over the management of the local Plan HMO, Blue Choice, which is offered to federal employees. Jennifer's department is now called FEHBP Account Management and OPM Relations. She will discuss which changes are OPMdriven and which are Plan-driven, and if any of the changes are the result of the Affordable Care Act. Any benefit changes that affect enrollees of Medicare Parts A and B will also be discussed.

The Office of Personnel Management officially announced the dates of the 2015 Federal Employee Health Benefits (FEHB) Open Season, which will run from Monday, November 9<sup>th</sup> through Monday, December 14<sup>th</sup>. New for this open season is the Self-Plus-One (SPO) Enrollment type. You may call 1-800-332-9798 to speak to a customer service representative who will be able to answer general questions about SPO. Congressman Chris Van Hollen will be hosting his 12<sup>th</sup> annual FEHBP Forums (see the "Upcoming Events," front page of this newsletter, for dates and locations).

I want to remind everyone about the Membership Recruitment Drive reported in the October newsletter, which runs from September 1<sup>st</sup> through December 31<sup>st</sup>. In addition to the information contained in Dick Strombotne's *Membership Report* in this newsletter, recruiters will be entered into a drawing for the Grand Prize of an Apple iPad Air 2 (one entry for each member you have recruited). Headquarters will also be sweetening the pot by selecting a winner in September, October, and November for a \$25 Amazon Gift card.
