Our 2018 meetings have gotten off to a great start with positive updates on the new tax code with our January speaker Terry Reinhart, CPA and our February speaker Jeannie Robinson- Hurley from the Maryland Attorneys General Office on the different scams operating in our midst to under mind our safety and well-being.

The federal income tax bill will increase the standard federal deduction for joint filers to \$24000. According to Maryland tax code if they claim standard deduction on your federal tax return you may not claim itemized deduction on your Maryland return. This may cause an increase in their Maryland state and local taxes of \$1000. on average who claim standard deductions in 2018 and after. Senator Serafini (R - Dist. 2) has introduce two bills in Maryland General Assembly to address this problem. His bills SB - 191 and SB - 318. Anyone with a Maryland Adjusted Gross Income of \$150,000 or less should contact your Senator and three Delegates and ask that they support SB-191 and SB-318 Telephone 1-800-492-7122.
