May 12th Meeting. President Dave Pyatt opened the meeting with the Pledge of Allegiance with about 27 members in attendance. New members, Kathy, Joe and Gary were introduced.

Dave and Program Chair, Don Champ both had very positive and complimentary comments in their introduction of today's speaker, Susan Krebs.

Delegate Krebs summarized the recently concluded legislative session in Annapolis. She discussed significant pieces of legislation that were passed and those that did not get approved. The legislature did not pass any significant changes to the state tax provisions. Maryland tax law only allows itemization of deductions if they are itemized on the Federal return. Therefore, if an individual takes the standard deduction on the federal return which was doubled, they cannot itemize on the State return. Delegate Krebs also said that Health Care costs are what is driving the budget and steps must be taken to get these costs under control. One of these costs is the "opiate crisis." This is being addressed from three directions: prevention, treatment and enforcement. She noted that opiates are a state wide problem. Carroll County has had 28 deaths from it so far this year. Don Champ, chairman of the nomination committee, offered the proposed slate of officers for the July 2, 2018-June 30, 2019 FY: President-Charles Harrison, VP Membership-Roger Dahlman, Treasurer-DeAnn Johnson, and Secretary-Paul Beatty. There being no other nominations, a motion was made and seconded to accept the slate of officers. The slate of officers was unanimously approved. Don asked members to strongly consider VP for Legislative matters. Charles Harrison will continue to do this job while taking of the duties of President. We need someone to step up and assist him in this most important position especially at this time when our earned benefits are being threatened.
