# **Tax Time is Coming**

Just a reminder if you have not adjusted your federal and state income tax withholdings or estimated quarterly payments. The 2018 Federal Tax Act canceled your personal exemptions, but significantly increased the standard deduction. That may actually save you some money via a larger refund in April. Your employer or the IRS.gov has updated withholding calculators.

However, Maryland did not accommodate those changes. If you were a federal Schedule A itemizer, but cannot match the increased deduction amounts, you may end up owing quite a bit more to Maryland come April. Again, check with your employer or use a computer tax program to estimate your new state tax. You can also check with your local tax advisor. # **LEGISLATIVE UPDATE** Shelly Ziman

The Office of Personnel Management (OPM) announced the average Federal Employees Health Benefits (FEHB) Program premium for America's retired and active federal workers will increase 1.3 percent in 2019, with the average enrollee's share rising 1.5 percent.

Even with this very modest premium increase, federal employees still face the prospect of their take-home pay decreasing due to the proposed federal pay freeze. It is up to Congress to step up to prevent that from happening. Unfortunately, it appears House and Senate negotiations have stalled on the appropriations bill that, if passed, would provide a 1.9 percent average pay increase, and the decision on federal pay likely will be delayed until after the election.

Open Season, the annual period when eligible federal employees, retirees and survivors can make changes to their health benefits coverage for the following year, will be held November 12 through December 10, 2018.

# Pension Income Tax Treatment by State Governments

There is a pending Supreme Court ruling involving West Virginia which will determine whether <u>federal retirees</u> throughout the country may be subject to a different set of state tax rules than <u>state government retirees</u>.

NARFE HQ has argued that State governments must not be permitted to carve out exemptions to the existing general rule that state and federal government pension income must be subject to the same tax treatment.

If this permission is granted, more and more states will follow the lead of West Virginia, and it is likely that other states will eventually be allowed to <u>tax federal pensions while</u> exempting State pensions.

So stay tuned.
