COLAS: Based on the latest consumer price data released by the Bureau of Labor Statistics, the 2019 COLA for Civil Service Retirement System (CSRS) annuities and Social Security benefits will be 2.8 percent. This is the largest COLA for CSRS retirees and Social Security beneficiaries since 2012. Meanwhile, retirees under the Federal Employees Retirement System (FERS) will not receive the full amount and instead will only receive a 2 percent COLA to their annuities.
