# **LEGISLATIVE UPDATE**

# Here are some of the hottest issues currently at NARFE HQ:

- Oppose the president's fiscal year 2019 budget. It contains proposals that decrease the earned pay and benefits of federal workers and current retirees, including eliminating COLAs for current retirees and implementing a pay freeze in 2019.
- Prevent Federal benefits cuts. If the administration policies are implemented, hundreds of billions of dollars in earned benefits would be stripped from both federal employees and retirees.
- Oppose the President's reorganization plan, which includes various proposals that would put the federal community at risk and threaten government services provided to the American public.
- Support the Equal Treatment of Public Servants Act. This legislation would offer much-needed relief to more than 1.8 million Social Security beneficiaries impacted by the Windfall Elimination Provision (WEP). The WEP unfairly reduces the Social Security benefits of federal retirees in the Civil Service Retirement System (CSRS).
- Support the CPI-E Act of 2017. This would require the use of the Consumer Price Index for the Elderly (CPI-E) instead of the current Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W). These determine annual cost-of-living adjustments (COLAs) for federal and military annuities and certain veterans' benefits. The CPI-E would result in more accurate COLAs that reflect seniors' spending habits.

#### Member Meeting Minutes - Oct 18, 2018

President Greg gave the opening remarks and introductions. He also led the Chapter in a moment of silence and the Pledge of Allegiance. There were 12 members in attendance. The location of the meeting was at the Adams Rib restaurant in Prince Fredrick following a luncheon from the menu at Adams.

The speaker was Mary May from Blue Cross/Blue Shield. She gave a presentation on Federal Health Benefits. The main topics for the 2019 updates were the results of lifestyle changes and restricting opioids medication. The premiums this year are about the same or will be down slightly from last year. The self only option was the only exception with an increase of nearly 2 %.

The new Basic coverage has an option to reimburse members up to \$600 for Medicare premiums and also includes lower premiums and changes to prescriptions. This also include the cost of diabetic supplies and hearing aids.

There is a new plan this year called Blue Focus which is for someone who has a managed condition. She also talked about the rates for vision and dental which will decrease in 2019. For dental and vision be sure to use an in network doctor and Blue Focus.
