**Election Day is Tuesday, November 6th** -- **don't forget to vote.** Early voting starts Thursday, October 25th through Thursday, November 1st. Check your Voter Guide for the location of an Early Voter Center near you. Remember, it is your responsibility to vote in every election.

**Our November 9, 2018, Chapter meeting will be on health insurance**. We have invited representatives from two insurance providers to talk about changes to their plans: Jennifer Malave, Account Manager, CareFirst Blue Cross Blue Shield, and Sekow Mitchell, from Aetna Direct.

**Plan to attend the Chapter's 2018 Holiday Party** on Wednesday, December 5th, at Alfio's La Trattoria Restaurant, 4515 Willard Ave., Chevy Chase, MD, with entertainment provided by the Conservatory Classic Jazz Band. See the reservation form in this newsletter.

**For those who missed the October Chapter meeting**, our guest speaker was Connie Morella. Connie represented Maryland's 8th Congressional District in the U. S. House of Representatives from 1987 to 2003. She served on the Committee on Science and chaired the subcommittee on Technology. While in the House she successfully initiated legislation addressing domestic violence, child support, programs for the elderly and human rights issues. Connie stated that during her time in the House members would meet one day a week (Tuesday Club) to discuss pending issues and whether to support the issues. However, with the current extreme polarization in Congress, she believes meetings to discuss issues have been replaced with meetings to discuss the individual parties and what is good for each party (Republican & Democratic). Members spend about 30 percent of their time fund raising for their individual party.

Connie taught at Montgomery College, Rockville Campus in the 1970's. During that time she was also appointed to the Commission for Women and worked to improve women's place in society and allowing them to succeed. Women applying for credit cards were required to have their husbands' signature and they could not get employment if they were pregnant. After leaving the U.S. House of Representatives, Connie served as U.S. Ambassador to the Organization for Economic Co-operation and Development (OECD) in Paris from 2003 to 2007. She has served on a number of advisory boards and commissions: elected President of the U.S. Association of Former Members of Congress; the George C. Marshall Foundation; and Advi-

sory Board of the Comptroller General, U.S. Government Accountability Office, to name a few.

**COLA Announced for 2019.** Based on the latest consumer price data released by the Bureau of Labor Statistics, the 2019 COLA for Civil Service Retirement System (CSRS) annuities will be 2.8 percent. Meanwhile, retirees under the Federal Employees Retirement System (FERS) will receive 2.0 percent. NARFE President Richard Thissen has written that the current COLA formula does not accurately account for the spending habits of seniors, and therefore retirees are not fully protected from rising consumer prices.

CSRS annuities are adjusted according to the change in the Consumer Price Index for Urban Wage Earners (CPI-W) from year to year, based on the average of the third-quarter months of July, August and September. Pursuant to federal law, when the CPI-W increases between 2 and 3 percent, FERS COLAs are unfairly capped at 2 percent. NARFE opposes this policy and is urging Congress to ensure FERS retirees receive the full COLA necessary to protect the value of their earned annuities from rising inflation.

**Volunteers are still needed for a Nominating Committee**: Chapter elections are planned for May 2019. The Committee needs to identify volunteers to fill three Board positions for the next two-year period. The three positions are President, 1st Vice President, and 2nd Vice President. Anyone interested in serving on the nominating committee and/or interested in filling one of the vacant Board positions, please contact either myself or other Board members.

**The NARFE Recruitment Drive is back.** NARFE Headquarters and the Maryland NARFE Federation have again instituted the **Membership Drive for 2018**. The recruitment period runs from September 1 through December 31, 2018. For each new member recruited the recruiter will receive \$10.00 from NARFE and an additional \$10.00 match from Maryland NARFE. Applications must be postmarked, calls to NARFE, or website applications for new memberships must be received at NARFE Headquarters by December 31, 2018. In order to receive credit for recruiting an applicant, don't forget to include, on the application, your name and NARFE membership number, which can be found on the label of your narfe Magazine.

## Tell your Mont Co legislators your views on itemizing deductions on your MD tax return.

On November 14, the Montgomery County delegation to the General Assembly will hold a joint hearing at 7:00 pm. It will be held at the Montgomery County Council Office Building, 3rd floor hearing room, 100 Maryland Avenue in Rockville. For more information, see the website

If you can't get to the hearing, send a letter or email or call your state Senator and Delegates and let them know what you think about losing the opportunity to itemize deductions on your MD income taxes because you claim the standard deduction on your federal tax form for 2018. It is too late for them to do anything about 2018 taxes but not too late to take care of the situation for taxes in 2019 and later years when the General Assembly meets next year.
