LEGISLATIVE UPDATE

MARYLAND STATE TAXES [excerpted from Winter Federation Newsletter, by Paul Schwartz1

- Maryland is a high tax state.
- Nine states have no income tax.
- . Nine other states exempt the total amount of civil service annuities.
- Five additional states exempt certain Federal civil service annuities.
- Seniors receive a relatively minor tax break in Maryland.

Are you angry yet? Well if you are a Maryland taxpayer who ordinarily had itemized deductions on your Maryland state tax returns. then you should be!

Who should you be angry with, you ask? With your elected officials in Annapolis who

failed to protect you from the tax hike imposed on your 2018 state income taxes resulting from the federal tax plan passed last year and effective on your 2018 taxes.

There were bills that called for decoupling state deductions from federal deductions that never made it out of committee. As in the past years, itemization at the state level is linked to the Federal Schedule A; if you take the new increased standard deductions on your Federal return, you are precluded from itemizing on your Maryland state return.

Failure to act is costing MD taxpayers an estimated \$500 million! Until it is addressed, Maryland taxpayers will continue to experience the state tax hike year after year after year. Moreover, the longer it takes to fix the injustice, the more used to the windfall and the spending ability that comes with it will be our elected officials.

Why, then, did your legislators really fail to correct this easily correctable problem? The Ways and Means Committee received guidance from Comptroller Peter Franchot's office and the Maryland Association of Certified Public Accountants (CPAs) who warned that there are administrative complexities in doing so. Thus, the Committee did not pass the bill.

Bottom line? There is power in numbers and if you want this injustice fixed, every one of you must make your concern heard by the very elected officials who turned a blind eye to fixing it last year.

How do you make your concerns raised to your legislators? Google "MD NARFE", click on the "Maryland Federation of NARFE" and then click on "Legislative -State Page" in the upper right-hand corner. You will then have access to "What you can do about it." Click here This link will enable you to directly contact your elected officials in Annapolis, as well as provide you with a sample letter that can be used in the process.

It is REALLY user friendly. Time to get angry and time to express that anger in a productive manner. Go for it! The money you save will be your own.

NARFE/MD NEW VOTING PROCESS

MD Federation Newsletter

One Member – One Vote (OMOV) Starts in 2019. The approval of the Federation Bylaws changes at the 2017 MD Federation Mini-Convention ended delegate voting for transacting the business of the MD Federation. OMOV provides each member of the MD Federation and National Only members who live in Maryland the opportunity to cast a ballot for election of officers, bylaws changes and resolutions.

To implement this change, 2019 voting will be done by paper ballot. For members who have email, the ballot will be sent by email to print, fill out, stamp and return by postal mail, based on instructions on the ballot. Non-email voters will need to request a paper ballot be sent to you for voting. To request your ballot, please send a self-addressed, stamped envelope to: Maria Ray, Ballot Coordinator, P.O. Box 47097, Windsor Mill. MD 21244.

In order for your vote to count, you must sign the ballot and provide your NARFE member ID number. These ballots must be returned in a timely manner and postmarked no later than April 15, 2019 for your vote to count. Detailed instructions will be included in the ballot you receive.

An Election 2019 Page has been set up on the Maryland Federation's website www.mdnarfe.org for information about the election and balloting. See NEWS AND EVENTS and click on the Election 2019 link. The slate of candidates, proposed bylaw changes and resolutions will be available by March 1, 2019 and published by March 22, 2019. All ballots will be distributed by March 25, 2019.

Medical Marijuana in Calvert County

I contacted the Calvert County Health Department of 'Community Health' . The Health department is not involved in medical marijuana nor had any summary of what was legal. It is still unlawful to possess or use marijuana under federal law.

I called the Sheriff's Office who informed me verbally that 1- you had to get a prescription from a doctor and 2- a registration card since use of marijuana would be prescriptive. You should use it at home, keep your supply at home and avoid using it in public. Always keep your patient registration card with you.

There is also a site listing MD doctors who prescribe marijuana: click here The closest on is Greenway Health Services in Dunkirk: click here or call 410-774-5454. This private practice provides comprehensive medical marijuana evaluations and certifications for eligible patients seeking to legally use cannabis.

Patients will be seen by Dr. Naomi Ihedioha, a state approved certifying physician for the Maryland Medical Cannabis Commission (MMCC). The physician will assess whether or not the use of medical cannabis may be an effective alternative to traditional modes of treatment, as well as discuss its associated risks and benefits.

Gateway Healthcare Services also offers assistance with completing the Patient Registration Process to obtain the MMCC Patient ID Number. Any approved patients will be issued a written certification for medical cannabis, permitting the legal purchase of the medicine from a Maryland licensed dispensary. A \$200 fee is required.

2019 Budget Proposal

Bob and I reviewed the expenditures for 2018 and compared to the 2018 Budget. Chapter spent less than 2018 budget allowed and income was also less. Net gain for year was \$99.

Proposed 2019 Budget includes increase in Newsletter expense during to pending increase in postage costs and possible increase in printing cost. Federation head tax was retained even though the Federation chose not to collect it in 2018. Chapter Administration was scaled back while meeting expense was doubled (as this includes cost of speaker gift mugs). Small amounts of money were added to the Convention and Meeting/Training attendance categories to make the budget budget-neutral.
