President's Corner

We are living in trying times. Some federal workers are facing some of the most difficult times ever with the recent furlough that, as of this writing, had lasted longer than any federal government shutdown in history. We, as a chartered federal chapter of NARFE must and should do all within our power to assist whenever and wherever we can. The following abstract was taken from the Prince George's County Council Web site and hopefully will assist those eligible. (As of this writing, a second furlough has been averted; however, if another furlough is called in the future, the following information may be helpful). County Residents Furloughed Due to Federal Government Shutdown May Be Eligible for WIC.

LARGO, MD - The Prince George's County Health Department wants to ensure residents who are furloughed federal government employees and contractors know they may be eligible to participate in the Women, Infants, and Children (WIC) assistance program.

Persons from families with adult members who are furloughed shall be eligible based on income during the period of unemployment if the loss of income causes the current rate of family income to be within the income guidelines for program eligibility (paste the following into your Web browser) (https://phpa.health.maryland.gov/wic/Pages/wiceligible.aspx). On a brighter note, our chapter has been doing well with attendance and with our guest speaker program. Last month we had Mr. Terry Reinhart enlightened us on the new federal and state income tax laws.
