LEGISLATIVE UPDATE

Discriminatory State Taxation

From NARFE HQ: "The Supreme Court's unanimous decision in Dawson v. Steager protects federal employees and retirees from unfair, discriminatory tax treatment by state governments. It makes clear that states may not grant special tax treatment to some of its current and former employees without providing the same tax treatment to similarly situated federal employees and retirees.

This decision prevents states from carving out one exemption after another for its own employees, only to shift that tax burden to federal employees and retirees. ... This sends a strong signal to state governments that discriminatory tax treatment of federal employees and retirees is not permitted." Stay tuned for action from the Maryland government.

Pay Raise

The FY 2019 omnibus legislation passed in February by the President included a 1.9 percent average pay raise for federal employees. NARFE HQ responded with, "... Providing federal employees with a modest increase in pay is long overdue common sense. Lagging behind the private sector for decades when it comes to competitive salaries, the federal government needs to maintain a wellqualified and high-performing workforce now more than ever. This average 1.9 percent pay increase is a small, yet positive, step to ensure the federal government can recruit and retain the best of the best for the benefit of the American people."

Federal Real ID Act **Required Documentation for Security**

The Federal REAL ID Act requires Maryland drivers to bring in documentation of age and identity, social security, and two proofs of Maryland residential address to meet federal security standards for state-issued licenses and identification cards. Meeting this requirement will give them the ability to visit federal government facilities and fly on airplanes using a state issued Driver's License or Identification Card.

To avoid long lines, appointments can be made at the offices of counties adjacent to Calvert, but not at the Prince Frederick satellite office (open M-T-W only).

All MD drivers will be notified ON A STAGGERED BASIS sometime before October 2020, based on their license number. A single date for all would presumably have created chaos at the MVA offices. Some details:

- -- No additional license fee
- -- No additional eye test
- -- New photo may be required
- -- Your current expiration date will be unchanged

Maryland Tax Bills Effecting You Greg

These bills were briefly discussed at our Feb 21 Chapter meeting. All of these bills have been through their initial hearings and will be pushed forward or not pushed forward by the Ways and Means and Budget and Taxation Committees

HB0327 Allowing an individual to itemize deductions to compute Maryland taxable income whether or not the individual itemizes deductions on the individual's federal income tax return; ... applying the Act to taxable years after 2018.

HB0271/SB0087

Increasing the minimum and maximum limitation amounts of the standard deduction allowed under the Maryland income tax; ... applying the Act to taxable years beginning after December 31, 2018.

HB0609

Altering a limitation on claiming the income tax credit for eligible long-term care insurance premiums by allowing the LTC credit to be claimed for every taxable year in which the insurance policy is in force; applying the Act to taxable years beginning after December 31, 2018

Committee meetings take place in rapid fashion during March. Most are open to the public-but their scheduling is frantic as March proceeds.

REAL ID and MD DRIVERS LICENSE

Post 9/11, Congress passed legislation that requires enhanced security standards for all state issued drivers licenses and identification cards. REAL ID requires that each state and their ID cards be compliant prior to October 1, 2020 in order for individuals to travel by commercial aircraft or to have access to federal facilities.

One time only, REAL ID requires all ID/license holders to submit proof of identity documents to the state DMV. This includes proof of any name changes, proof of age and state residency. Typically, U.S. birth certificates, or passports, social security cards and two examples of MD residential address will suffice. There may be a \$20 charge.

CHAINED CPI CUTS EARNED BENEFITS

NARFE HQ When you measure costs experienced by Americans age 62 and older, as the BLS does when calculating an experimental price index for <u>elderly</u> consumers, the CPI-E, inflation is actually greater than what the CPI-W (wage earners) reflects; a clear sign that switching to the Chained CPI is a move in the wrong direction.

Using the Chained CPI instead of the current CPI-W would reduce COLAs by an estimated 0.3 percent per year. Because this difference would compound over time, it would result in estimated yearly benefits 3 percent lower after 10 years, 6.2 percent lower after 20 years and 9.4 percent lower after 30 years.

Federal retirees under the Civil Service Retirement System (CSRS), which does not provide Social Security benefits, often rely solely on their federal annuity as their source of income. Therefore, a switch to the Chained CPI would have a particularly acute impact on their retirement benefits. The median CSRS annuity is \$35,600 annually. By using the Chained CPI, someone earning that annuity would lose, in total actual dollars, an estimated:

- \$6,969 after 10 years;
- \$32,306 after 20 years;
- \$87,203 after 30 years; and, if lucky enough to enjoy a long life, \$188,190 after 40 years


