Member Meeting Minutes - May 16, 2019

Greg gave the opening remarks, and then led the Chapter in the Pledge of Allegiance and a moment of silence. There were 12 chapter members in attendance. One transferee from 1363 Theresa Pyne was present. The Keep Calvert Country speaker was unable to make the meeting. Greg gave a slide presentation on the county comprehensive plan and a counterpoint from Keep Calvert Country.

One of the goals of KCC is to include the infrastructure for the development, and to manage the growth in the Prince Frederick area. The town centers are mostly for commercial development. KCC wants to have parks, schools and a mix of housing added to the town centers. They are also sponsoring land use restrictions. Bob Priddy talked about adding solar and wind power into the county. He suggested adding solar to the fire houses, schools and public buildings.

Greg also passed out a two page report on the NARFE Biennial State Conference just held by the Maryland Federation in Ocean City. The 50/50 raffle was won by Greg. The prize was \$37 and was donated to the Alzheimer's fund.

Review of OPM Reorganization Proposal

On June 21, 2018, the Trump Administration released a proposal to reorganize the U.S. Office of Personnel Management (OPM), particularly by transferring five program offices to other agencies. Under the proposal, functions of three program offices would be transferred to a "Government Services Administration" (currently the General Services Administration, or GSA):

- -- Human Resources Solutions (HRS),
- -- Healthcare and Insurance (HI), and
- -- Retirement Services (RS).

The agencies intend to implement the transfers using a phased approach, with the first phase focusing on integrating HRS functions into GSA.

NARFE National President Ken Thomas testified at the House on why the administration's proposed merger of OPM with GSA lacks transparency and sufficient planning. Under this new office, civil service policy would ultimately be beholden to the President – a threat to the nonpolitical, meritbased civil service we have today. This raises red flags and concerns that the move is part of an effort to exert undue political influence on career hiring and firing decisions.

Congress clearly intended OPM to be an independent body to ensure a politically neutral, merit-based federal workforce, and for Congress to be the only authority able to change OPM's core mission.
