#### **PRESIDENTS' CORNER**

**Maryland Federation President Dr. Gary Roundtree**, Sr. hosted the 2019 NARFE Federation Presidents Meeting in Scottsdale, Arizona, July 7-10. Included in his report to NARFE National President Ken Thomas on meeting outcomes were priority issues that would be addressed individually in future correspondence. Among the issues cited was establishment of a Federation President's advisory committee, in-depth training for Chapter and Federal Service Officers, improve communications, send a bill instead of a membership renewal form and various tactics focused on attracting younger members. Barbara (Barb) Sido, Executive Director of NARFE responded to Dr. Roundtree's report concerning follow-up activities. Incidentally, we look forward to meeting with Barb Sido at the Chapter 258 meeting on March 13, 2020.

**The Bipartisan Budget Act of 2019** raises defense and domestic spending by about \$100 billion and extends the debt ceiling through July 31, 2021. Fortunately, it doesn't take funds from federal employee retirement accounts, and avoids automatic spending cuts through sequestration. However, 12 appropriation bills (or a continuing resolution) must be passed by Oct. 1 to avoid federal agency shutdowns.

The speaker for the September 13 Membership Meeting will be Dr. Roland F. Hirsch, who was a faculty member and associate dean at Seton Hall University, worked at NIH for three years and at the Department of Energy for 28 years where he managed research in the Office of Biological and Environmental Research, involving climate research, genomic research and biogeochemistry. Dr. Hirsch's work gave him the opportunity to learn about the broad range of scientific work in the climate area. The presentation from this award winning, highly respected scientist will give us a special insight into Climate Change.

**Our annual Maryland State Legislators' Forum** took place at the previous Membership Meeting on May 10, when guest speakers included Senator Susan Lee (District 16), Senator Benjamin Kramer (District 19) and Delegate Kirill Reznik (District 39), who presented the outcome of the 2019 Maryland Legislative Session. Accomplishments included a \$46.7 billion balanced budget without raising taxes or fees, a Rainy Day Fund with over \$1.1 billion, \$118.2 million of unspent revenues and additional state

resources over \$119 million for the support of critical projects in Montgomery County. Improvements to the education system, anti-violence actions, updating Maryland's Human Trafficking law, fighting elder fraud, cybersecurity, restoration of the health of Chesapeake Bay, and a gradual increase in the minimum wage and other achievements were cited. Local bond funding was obtained to support renovations for Cornerstone Montgomery, Josiah Henson Park, YMCA Bethesda-Chevy Chase and CASA de Maryland.

# NARFE MARYLAND FEDERATION'S 44TH BIENNIAL STATE CONFERENCE

The Maryland Federation's 44th Biennial State Conference was held in Ocean City, Maryland, at the Dunes Manor Hotel and Suites from May 5th through the 7th. Past Chapter President Charlie Garfinkel and I attended. The Host Chapter was Ocean Area Chapter 2274; Larry Walton is President of Chapter 2274 and was Conference Co-Chairman. Dr. Gary Roundtree, Sr., Conference Chairman, described this meeting as a "one-ofa-kind leadership and training" opportunity. Speakers for the first day's program included Mr. Rick Meehan, Mayor of Ocean City, and Mr. Gee Williams, Mayor of Berlin, MD, both of whom welcomed the attendees. The keynote address was delivered by Mr. Peter Franchot, Comptroller of Maryland, who was followed on the podium by Ms. Barbara Sido, NARFE's Executive Director (She is scheduled to speak at our March 13, 2020 Chapter 258 membership meeting).

Among the many other speakers were the Maryland Secretary of State, Mr. John Wobensmith; Speaker Wayne Hartman, Maryland House of Delegates; Mr. James Marshall, Head of NARFE's Federal Benefits Institute; Mr. Ronald Rolfe, Deputy Assistant Director, Nuclear and Missile Technology Division, U.S. Department of Commerce's Bureau of Industry and Security; and Ms. Cara Rose, Senior Special Agent, Human Trafficking, Homeland Security Investigations. The afternoon of Monday, May 6th offered attendees four different workshops (from which they could choose two). One of these workshops that I attended was on Elder Law, given by Leslie Case DiPietro, Esq., of Procino-Wells and Woodland Law Offices; I found Ms. DiPietro's presentation to be very interesting and informative.

The Dunes Manor Hotel and Suites is located at 28th Street in Ocean City, a short distance from the boardwalk. All rooms for the Conference attendees, which faced the ocean, had been recently updated. The hotel's meeting, workshop rooms, and the dining rooms were excellent.

An enormous amount of work, over several months by every member of the Conference Planning Board made for an interesting, informative, and thoroughly enjoyable experience.
