The NARFE Bill Tracker is your monthly guide to the National Congressional legislation that NARFE is following because of its import to Federal workers and retirees. For the latest information in an easy to read table format, see pages 12, 13, and 14 of the November NARFE magazine. Currently, a few items listed discuss postal reform, the new formula for the Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP), Federal annuities, and Federal compensation.

Regarding the State Legislation: Paul Schwartz, Chapter Vice President, sent an open letter in the Sentinel Newspapers to Governor Hogan and Members of the Maryland State Legislature asking for our state taxes to be fixed.

Protect your TSP Account

You can lose your TSP funds if someone hacks your account. There is no insurance that protects your money should that happen. Whether to reimburse you or not for those lost funds is decided on a case by case basis by the managers of the TSP.

Protect your money by setting up the two-step authentication for your TSP account as soon as possible. Two-step means that a password is just the first step to accessing your account. The second step is for you to key in a special code sent to your cell phone or email real time. Everyone will be required to use two-step access in 2020 when you try to log in. Best to protect your funds now. Just go to the TSP website and try to access your account, the system will ask if you want to set up the two-step authentication. Follow the instructions. It's easy. You'll rest better knowing your funds are better protected.

Members heard from Maryland Lt. Governor Boyd Rutherford who said he supported us on the tax issue and took printed information from us that he promised to read and address. The luncheon speaker, George Ownings, Maryland Secretary of the Department of Veterans Affairs (VA) was dynamic and spoke of his project to add VA offices in stores and other public areas to improve veterans' access to help. He discussed his VA biweekly electronic newsletter, *Home and Living*, that also provides information for veterans. He urged us to tell our veterans that there are services available for them that most people don't know about and to encourage veterans to visit the VA offices and their website: *Veterans.Maryland.gov.*

Watch Out!!

Recently, someone pretended to be our President and asked the Chapter Board members for money to be sent to a vendor's account. Thank goodness, our Board members did not believe this fraudulent message. The NARFE Maryland Federation President's name also was used in the same way and the message sent to the Maryland Federation Board members. Many other NARFE chapter presidents' names were also used in this way. Be wary of any message that asks you to send money. Always check the email address to be sure it's from the person the message says it is. In our case, the email address was incorrect and was a clue that the message was fraudulent.
