If we are to resist those attacks, we must keep informed almost daily on who is attacking us, what they propose to do to us, and what NARFE is doing to fight back.

The best way to keep informed is by enrolling in GEMS, a NARFE headquarters service that sends frequent updates on happenings on Capitol Hill that may affect us. Proposed Changes to Bylaws

ARTICLE IV. MEETINGS, QUORUM, AND ORDER OF BUSINESS

Section 1 of our Bylaws currently states: Regular Chapter membership meetings shall be held on the second Friday of each month as determined by the Board of Directors.

Proposed amendment: Regular Chapter membership meetings shall be held on the second Fridays of September, November, February, April, and June, or as determined by the Board of Directors, or by vote of a majority of members attending a regular or special membership meeting. (I think this gives the Board discretion in setting meeting dates and it also lets the membership hold more regular meetings if they want to.)

No change in the rest of that Section; that Section also says: Special meetings of the Chapter may be called by the President. The Chapter Board of Directors shall set the times of meetings. A quorum is the number of members attending any meeting.

ARTICLE VI. ELECTION OF OFFICERS

Section 1 now says: Not later than the December meetings in even-numbered years, the President shall appoint the Chair of the Nominating Committee, and two additional members, one of whom shall be the Immediate Past President. The Nominating Committee shall present, at the regular Chapter meeting in March, the names of members nominated for each elective office, and stating that each nominee has consented to serve if elected.

We will not be meeting in December and March; *Proposed amendment: Change December to November in line 1 and change March to February in line 4.*

Section 2 of Article VI says: Election of officers will take place at the regular Chapter meetings in April of odd-numbered years. Chapter officers shall be elected by simple majority to two-year terms, and shall be installed at the June meeting to be effective as of installation.

ARTICLE X. NATIONAL AND FEDERATION CONVENTIONS.

Sections 1 and 2 deal with establishment and purpose of the National Convention Fund. I propose adding the following to Section 2, which deals with the purpose of the Fund.

Amounts remaining in the National Convention Fund after reimbursement of appropriate delegates' expenses shall be returned to the Chapter's general fund.
