Nancy Navarro, currently the President of Montgomery County Council, is the invited speaker for our chapter meeting. As President, Ms Navarro has been engaged in the budget proposal especially affecting programs for the aging population. Ms



Navarro was elected to represent District 4 on the Council in a special election in 2009 and re-elected in the general election in 2010. Since 2010, Nancy has chaired the Government Operations and Fiscal Policy (GO) Committee and serves on the Health and Human Services Committee.

Prior to joining the Council, Ms Navarro was a member of the Montgomery County Board of Education, where she served two consecutive terms as Board President. Before entering public office, Ms Navarro co-founded a non-profit, community-based organization with a mission to assist the economic and educational development of Latino and other immigrant communities. School readiness, healthy family development, and academic achievement were the primary focus of the organization. Nancy Navarro has volunteered for many organizations and has received numerous awards: the Hispanic Chamber of Commerce of Montgomery County's Leadership Award, the Maryland State Department of Education's Women Who Dare Leadership Award, for example.

Ms Navarro graduated with a bachelor's degree (psychology) from the University of Missouri-Columbia. She was born in Caracas, Venezuela and has lived in Montgomery County for more than two decades with her husband, Reginald, and two daughters.

## **November 8: Health Insurance Update**

November is the month that federal employees once again consider their choices in health insurance. On November 8, Ms. Jennifer Malave returns as our invited speaker. Ms. Malave's presentation will cover changes to Federal Employee Policy (FEP) - standard option and basic- in regard to Care First Blue Cross/Blue Shield plan. In addition, Jennifer will address the Affordable Care Act Initiative and how it will affect all FEP plans.

Ms. Malave has worked at CareFirst Blue Cross Blue Shield (BCBS) for 24 years. Jennifer started at BCBS as a customer service representative where she learned the benefits "like the back of my hand" and "when (businesses) still taught old school customer service skills such as the customer always comes first." Jennifer has valued this motto that has carried her into the other positions at CareFirst. Ultimately, she accepted the position as FEP Marketing Representative for CareFirst BCBS where she held the position for 14 years. Her department recently changed their name and her title. Her team recently took over the management of the local Plan HMO, Blue Choice, that is offered to federal employees and so the department is now called " FEHBP Account Management and OPM Relations." Her new title is too long to explain but in short, she is still an Account Manager.

Ms Malave's contacts include over 60 federal agencies, all of USDA, the Department of Labor and the Supreme Court, just to name a few, as well as 10 NARFE chapters. She especially enjoys working with NARFE members because she finds them to be one of the most well-informed groups. In addition to her work, Ms. Malave is involved in antiquing and continues her hobby of refurbishing used furniture. She lives with her family in Alexandria, VA.

## **Legislative Report**

The Maryland General Assembly ended its 433rd session in April during which 692 bills were enacted, among the bills:

- Repeal the death penalty in Maryland; a person who is convicted of first degree murder must be sentenced to life imprisonment or life without possibility of parole.
- Impose some of the strictest gun control measures in the country.
- Increase Medicaid spending by \$251 million, a 3.5% increase.
- Bring State laws into conformity with the Federal Patient Protection and Affordable Care Act; some of these provisions will be in effect Jan. 1, 2014.
- Increase the number of early voting centers in certain counties; the law also establishes more days and extended operating hours for 2014.
- Montgomery County will benefit by \$1 billion in State support in 2014, some of that in direct aid, and some in expanded retirement payments, operating assistance for mass transit programs and programs focused on health, mental health, developmental disabilities, alcohol and drug abuse treatment, prevention and disease control, and child welfare services. The State will also provide operating assistance for Metrorail, Metrobus, and Ride-On.
