A word about programs coming up early in the year: January will feature the traditional discussion on income tax preparation. At this point in time, I am sure that speaker Helen Berkson has no idea how to prepare for her talk! It should be a lively discussion with lots of questions. In February, Asbury's Fitness Director Cathy Moxley or one of her assistants will convince us why we can't just sit around this winter. We have to keep moving and exercising. The focus, which we personally have learned we can no longer take for granted, is leg strength and balance. Expect to move around a little as we learn how to remain mobile as long as possible.

As the saying goes, "the most constant thing about life is change." We had a different venue this year for our December Chapter 581

Holiday Party: O'Donnell's Sea Grill in the Kentlands area of Gaithersburg. The ambiance, the meals, and the service were excellent, and the private room was especially appreciated. The entertainment was again supplied by the actress Mary Ann Jung, who this year portrayed "Elizabeth Cady Stanton - Cyrano of the Suffragists." Added fun was when "Mrs. Stanton" pulled "volunteers" from the audience to help her character portrayals "come alive." Another change: the United Seniors of Maryland annual rally in Annapolis, MD, usually scheduled for the end of January, has been rescheduled for Tuesday, March 19th. ## FEDERAL LEGISLATIVE REPORT

For the last two years, NARFE has had little success in persuading those in control of the House that we have been picked upon unfairly, and that others also should be called upon to contribute to resolving the nation's financial difficulties. Far from convincing them, measures were passed in the House, which would have made things much worse for the Federal Community, without any sharing of the burden, and we were saved by almost all of these proposals being defeated in the Senate.

It may appear that the control of the House, Senate and White House has not changed, after the election, so why should we expect any different response to our concerns? However, the polit-

ical parties are reassessing their guiding principles, based on the results of the election, which suggested that the public disapproves of politics that fails to seek out viable compromises, that move the country forward, and tends to heap more blame on one party than the other. Hence, to improve election prospects in the future, there needs to be changes in internal procedures for more effective legislation.

Hopefully this will mean that more respect will be paid, in the next Congress, to arguments put forward by NARFE on the basis of their intrinsic merit, and we can defend our interests better, because our critics will be less able to insist on a monolithic negative attitude to our concerns within their party. An early example, recently, was a declaration by nine members of the House, from Maryland, Virginia, and DC, to the President and colleagues in Congress, supporting the message that the Federal Community has contributed enough, and others should be called upon to share the cost reduction burden. The nine were made up of four Democrats from Maryland, two Democrats from Virginia, delegate Eleanor Holmes Norton from DC, and two VA Republicans - Frank Wolf and Robert Wittman. Frank Wolf has long been a solid supporter of the Federal Community, and bemoaned, on the floor of the House some months ago, the distorted understanding by his party of the many contributions the Feds make on behalf of the country. However, the significance here is that this is an indication that more politicians will listen more carefully to rational argument and act on their beliefs, with less fear that the repercussions will damage their political prospects. Hence, a better environment for NARFE to make its case.

However, it will still be true that NARFE will have a better chance of being persuasive, if we can emphasize the damage to the services provided to the country, if we are treated unfairly, rather than focusing more narrowly on how proposals will hurt us. A politician is more likely to be influenced by how voters will react to deteriorating federal services, more so than how fairly we are being treated.

Within Maryland, we intend to establish a relationship with all the staff of our Senators and Representatives, in Washington and at local offices. When the staff complements are published, we will expect the members of our Federation Legislative Committee to forge the initial links, and to cooperate with chapters to ensure that the information, flowing up and down, is as helpful as possible to NARFE getting is concerns across, and to us responding to whatever inputs they might welcome from us.
