There will be a District 6 and District 8 Candidates' Forum at Asbury on Friday, September 28th, from 1:00 p.m. to 3:00 p.m. in Parker Hall (we were not able to reserve the auditorium in the Rosborough Center for this event).

Members at the September 25th Chapter meeting will be asked to vote on the proposed 2013/2014 Chapter budget as it appears later in this newsletter.

This is Chapter 581's first newsletter of this NARFE year. You may notice changes in this issue. We are very appreciative of the years of diligent and tedious newsletter creation on the part of Tom Kitchens, Mary Anne Scott, and Judy Bernstein. Now we are trying to reduce the work-load involved in producing the newsletter. FEDERAL LEGISLATIVE REPORT

NARFE is a non-partisan organization with a membership that is spread all over the political spectrum. Hence, it is improper for NARFE officers to promote one party over the other, because there are many different aspects of policy which cause our members to decide on their choices.

However, we need to consider the reason for NARFE's existence which is to "defend the benefits and interests of the Federal Community" where there can be no doubt that one party is much more antagonistic to our interests than the other.

The budget passed in the House in 2012 makes this very clear. Savings from the Federal workforce would total \$368 billion over 10 years on top of the \$75 billion already being contributed by Federal employees. The freeze on basic federal pay rates would be extended to five years, and the Federal workforce would be cut by 10% over three years, amounting to a reduction of 200,000 positions.

NARFE President, Joe Beaudoin, commented that, "the belief behind this budget, that it is permissible to penalize middle-class federal workers, who protect Americans and keep our nation moving forward, is frightening."

This budget has not yet been implemented, because it was rejected in the Senate, but it has been made clear that it will be reintroduced next year, successfully, if the House and Senate are under the control of the party that promotes this budget. The damage to the civilian Federal Community could be even worse, if the cuts currently envisaged for the Defense and National Security sectors are reduced. The result would be that the roles and staffing of the Federal civilian sector would be a pale shadow of what has been provided in the past.

STATE LEGISLATIVE REPORT

The State General Assembly just finished its second Special Session this year and decided to vote for expansion of gambling in Maryland. The result will be a seventh question on the ballot this November. While no State Offices will be voted on this November (Governor, State Senators, and State Delegates) there is a lot going on in Maryland.

There will be seven questions on the ballot. These include approval or disapproval of:

- (1) Expanding gambling in Maryland to include table games and one additional casino site;
- (2) Establishes that individuals including undocumented immigrants are eligible to pay in-state tuition rates at community colleges in Maryland;
- (3) Establishes the boundaries for the eight U.S. Congressional districts; and
- (4) Establishes that Maryland's civil marriage laws allow gay and lesbian couples to obtain a civil marriage license.

This does not include a large number of local elections and questions. All of these will have strong and vigorous support on both sides of the issues. In addition we have U.S. Congressional seats being contested in the 3rd, 6th and 8th districts. Also, Senator Cardin is being challenged by Mr. Bongino. This is a time for all Marylanders to jump in and support the candidates of your choice. Hopefully we will have an educated and active electorate. There are many opportunities to participate actively. All the candidates are looking for volunteers. This is how grass roots democracy works. It's every citizen's duty to cast his or her ballot and participate in the electoral process. Oh, I almost forgot we have a Presidential race being decided. If you don't vote you can't complain after the election, so get out there and be a part of this great 200 year old experiment in democracy.

IN MEMORIAM –**Meredith G. Williams, Jr.**

We were very sorry to learn of the death of a long time and devoted Chapter 581 member, Meredith Williams, on Friday, June 29, 2012. Meredith earned a B.S. in physics from Bates College in 1944; during WWII he was an electronics repair officer on the USS Yosemite, a destroyer tender stationed in Sasebo Harbor, Japan. In 1947 he worked as an oceanographic technician at the Woods Hole Oceanographic Institution in Massachusetts. Following a distinguished 32-year career with the U.S. Navy, he retired in 1984 as head of the Nucleonics Branch. Meredith was active in the West Montgomery County Citizens Association and the Potomac Glen Association. He came to virtually every Chapter Board meeting,

NARFE LEADS NEW COALITION, "AMERICA COUNTS ON US"

Complementing NARFE'S Protect America's Heartbeat campaign, NARFE has joined (and is leading) a broad-based coalition of postal and federal employee and retiree organizations to advocate for our interests, and to put a public face on federal workers and retirees. The idea is to help our friends and neighbors recognize the role we play in their day-to-day lives, and to remind everyone of occasional headline heroic acts by federal employees. The federal-postal coalition includes 30 national organizations of unions and management (e.g., SES) at all levels, and represents nearly everyone in the federal community. What the coalition wants Americans to know about federal and postal employees includes the following:

- 1) "They are committed to their jobs for America and all Americans;"
- 2) "They are your neighbors and constituents;"
- 3) "They are middle-class Americans struggling to care for their families, too;"
- 4) "They are already contributing hundreds of billions of dollars toward budget savings" and;
- 5) "They are receptive to doing their share to help right the nation's fiscal ship, but cutting their pay and benefits cannot solve the nation's budget problems alone."

The "America Counts on Us" coalition plans aggressive eyeball advocacy with members of Congress to halt the non-stop attack on pay and benefits. See Jim Cowie's article in this NL for examples of potential impacts on federal employees. (More information about the coalition and the campaign can be found in the August issue of the NARFE magazine, pp. 20-22).

It is obvious that "America Counts on Us" is a logical extension of NARFE's Protect America's Heartbeat (PAH) program, and the skills and

experience of PAH provide a good model for leading the coalition. The strength in numbers of the 5 million coalition members will now provide stronger advocacy for our interests.

As we approach the November election, here is a reminder of things we can do as individuals to advocate for our interests as described in more detail in a previous newsletter (April 2012, p. 5):

Read the NARFE magazine;

- a) **Become informed of the issues and where candidates stand on them;**
- b) Visit the NARFE HQ website (<http://www.narfe.org/departments/home/index.cfm>) for up-to-date information on candidates' positions that affect employees and retirees;
- c) Monitor the **Protect America's Heartbeat** website <http://www.narfe.org/heartbeat/> for legislative and election alerts;
- d) Use the PAH website to easily **express your views to Congressional and Administration leaders;**
- e) **Register with GEMS** (Global Email Messaging System- https://www.narfe.org/updaterecord/update_record.cfm) to get weekly e-mail reports about federal activities of interest to us ; and
- f) **Participate in candidate forums and support candidates of your choice in the general election.**

(More information about each of these items is provided in the April 2012 NL)

Additional reminder: We still need your stories about how your federal service Protected America's Heartbeat. The stories are powerful examples of important contributions by current and retired federal employees to the safety, security and welfare of the United States. intact and not be cut into chunks requiring the reader to turn pages repeatedly to continue. Hopefully you will find this easy to read. We will still include photos from time to time.

By the time you read this, there will have been an election of officers during the NARFE National Convention as well as voting on other matters brought before the delegates. On November 6 there will be a much more important General Election, one involving the selection of candidates of our choice as well as referendums on certain state and local issues. You may want to think about what sort of society you visualize for the future and vote accordingly. But vote.

AUDIT REPORT

On July 11, 2012, the Audit Committee (D. Strombotne, Chair, and J. Padan, member) examined Gaithersburg Chapter 581's financial records maintained by Treasurer Larry Lange. The Audit Committee used the F-131 "Checklist for the Audit of NARFE Chapter Funds" as a guide.

The financial records of revenues and disbursement were found to be in excellent condition. The checking account is kept in a federally insured bank. Two persons have signature authority. A random sample of disbursement records included signed approval sheets. The Chapter's finances are reported to the Executive Committee at each Board meeting, are posted at each Membership meeting, and are summarized in each newsletter. In summary, the Audit Committee commends the Treasurer for his conduct of the Chapter's financial transactions and his meticulous record keeping.
