# FEDERAL LEGISLATIVE COMMITTEE (FLC) REPORT

On March 15, following the National Legislative Conference, your Federation's Senate Leaders (SLs) and Congressional District Leaders (CDLs) brought our **Crusade to Capitol Hill**. Your SLs and CDLs directed our delegations to all our Maryland Senators and Congressmen, to address our issues.

We know how unfairly public servants have been targeted. As drastic changes threaten federal employees' and retirees' earned pay and health benefits in the 115<sup>th</sup> Congress, we met with our lawmakers and discussed our concerns and gained their assurance to champion our issues. Your SLs and CDLs distributed the Lawmakers' meeting schedules to the Federation's chapters under their responsibility, and invited our members to join us on Capitol Hill on March 15.

Your Maryland Federation's Legislative Committee (FLC) is moving onward. A few years ago, NARFE Headquarters requested "Blurbs" on our Federal workforce's positive impact on Americans, to gain better leverage and elevate the general American public's attitude to our Active and Retired Federal Employees. We sent NARFE HQ short statements describing how we have kept and continue to keep Americans safe and secure, and improve American lives and living standards.

Your FLC plans to take it a step further. We are proposing cataloging, into a Portfolio, paragraphs of presentations about our workforce's valuable impact on the American public. We will share this Portfolio with our Maryland lawmakers, to help them spread the word to their skeptic colleagues and constituents, and help to improve public opinion about active and retired federal employees.

In this toxic environment, as the challenges grow to our Federal Community, our Portfolio will be patterned, albeit on a minor scale, after the grand work of our President John F. Kennedy, who gave us his "Profiles in Courage." Your FLC proposes

publishing our Maryland Federation's Portfolio of "Profiles in Civil Service." President Kennedy had cited "...A man (woman) does what he (she) mustin spite of personal consequences, in spite of obstacles and dangers and pressures—and that is the basis of a human morality!" # STATE LEGISLATIVE COMMITTEE (SLC) REPORT

Elections have consequences but none more so on the lives and values of every American citizen than the election of 2016. In addition to the onslaught upon the very values America has fought for throughout our history, the attack on the federal workforce and the social safeguards that citizens have come to rely on, the new administration and Congress will place a heavy burden on state governments to fill in the voids created by the

dismantling of the federal government and the programs managed by it.

Medicaid is just one example, and an expensive example at that. Medicaid is already at close to 22 percent of Maryland's budget. If the federal government no longer provides Medicaid funding to the state, Maryland will have to find another \$2 billion to make up the difference. This is a price tag that this state is not in position to easily absorb.

It is for this reason that NARFE testified before the State Senate's Budget & Taxation Committee on behalf of SB 432, which calls for tax incentives for the purchase of long term care insurance. The goal is to extend the period of time before Medicaid reliance kicks in. Moreover, prolonging the period of time a person can receive in home care and delaying the entry into a nursing home will likewise delay the need for Medicaid.

We are hopeful that this bill will finally get out of committee. Not so hopeful with tax relief for seniors. There are currently about three million seniors living in the state of Maryland and, of those, there are more than 850,000 over the age of 65. The senior club does at least one thing better than any other group; they vote. Accordingly, one must wonder why Governor Larry Hogan as well as the Maryland State Legislature have chosen to once again forget this rather considerable constituency when it comes time for some good old fashioned tax relief.

During the 2016 legislative session, you may recall, Governor Hogan did, indeed, put forward a bill to increase the tax exemption for seniors age 65 or older from \$1,000 to \$5,000 over a four-year period. No such bill for 2017. The explanation provided for not reintroducing last year's senior tax relief bill focused on the budget and the shortfalls in both the 2017 and 2018 fiscal years. That explanation completely ignored the sales tax offset as well as the increased tax revenue from the small businesses due to increased senior spending, which would make any lost revenue due to this tax break, as Comptroller Peter Franchot indicated to me, "negligible."

relief for first responders, hometown heroes and the single one of them! military. Obviously, the issue is not whether these individuals are worthy of a tax break. The issue is the hypocrisy of saying there is not enough money to offer a tax break for seniors, many of whom are on fixed incomes, and for which there is an offset to cost but, there is enough money, regardless of the budget shortfalls, to offer a tax break to any other group of people, no matter how deserving.

What needs to be done, you ask? Contact your legislators and contact the governor's office and don't ask them IF they support tax relief for seniors; ask them why they DID NOT support tax relief for seniors!

Again, let me emphasize that this is not about our first responders nor is it about our hometown heroes or our military or about the sacrifices they all make. This is about money; it is about hypocrisy; it is about politics; it is about needed tax relief for a key segment of our society; but, most of all, it is about the senior population of Maryland being taken for

Moreover, bills were introduced to provide tax granted by our elected officials in Annapolis, every

#### **FEEA UPDATE**

The NARFE Annual Scholarship Awards Program started February 2017. Each year National awards six \$1,000 scholarships in each region. The Maryland Federation in Region II has received five winners in the last three years. The criteria are for high school seniors with at least a 3.0 Grade Point Average (GPA) on an unweighted 4.0 scale. Now is the time to start the application process. Online-only application and submission is new this year. The essay topic is "Why was the Electoral College System established? Should it now be abolished or modified?" See page 44 of the March 2017 *narfe* magazine for the details. The regional judging panels will examine each application, essay and supporting documents.

There is a new form entitled "NARFE-FEEA Steve Bauer Scholarship Program." Mr. Bauer is the outgoing Executive Director of FEEA. The official form (F-105)(01/17) can be obtained by sending an email to <a href="mailto:scholarship@nafre.org">scholarship@nafre.org</a> or calling Headquarters at 703-838-7760.

Applications must be postmarked no later than that last Friday in April 2017. Winners will be notified by FEEA and the money will be paid to the college. A list of winners and their sponsors will be posted on the NARFE website and published in the December and January issues of the *narfe* magazine.

**FEEA Disaster Fund.** The FEEA/NARFE has a Disaster Fund to aid federal employees who are victims of declared natural disaster. Cash grants up to \$500 maximum are available to NARFE members in good standing who have been injured, incurred property damage or have other needs during and

#### TREASURER'S REPORT

Finances as of End of 2016. At the start of 2016, the Maryland Federation's net assets totaled \$93,422.92. At the end of the year they totaled \$89,941.65 for a net annual deficit of \$3,481.03. The most significant revenues came from tenpercent funds (\$49,300). Chapter per capita assessments were \$6,352.

Expenditures were spread across several major categories (rounded): Federal Legislation (\$13,880), National Convention (\$9,250), Mini-convention (\$8,590), Federation Board meeting (\$6,810), Chapter Assistance (\$6,630), Training (\$5,760), Executive Committee (\$4,940), and State Legislation (\$4,760). Other expenditures came in at \$2,000 or less.

2017 National Legislative Training Conference. Maryland NARFE will reimburse attendees to the NLTC as follows: Members of the FLC will be reimbursed for registration and for one night of lodging or mileage and parking cost up to the equivalent of one night of lodging. For attendees from chapters that don't send a member of the FLC, reimbursement will follow the same policy. The \$175 registration fee covers the costs of several meals, among other things. The cost of lodging for one night is \$194.51 (\$169 plus taxes).

Maryland State Convention in Ocean City. Registration for the convention is \$45 per person and covers the costs of two lunches. The Banquet fee is also \$45. Each chapter should send me separate lists of attendees and banquet reservations. Do not send payments for people that the Federation is covering. Above all, read the Call letter and follow the instructions.

#### Prompt deposit of reimbursement checks.

Outstanding checks are a problem for the financial accounting system. If you receive a reimbursement check from Maryland NARFE, please deposit it promptly. If you do not want to be reimbursed for an event or activity let me know so I can take you off the list.


