PRESIDENT'S MESSAGE



Dr. Gary Roundtree Sr.

John F. Kennedy once said, "We choose to go to the moon in this decade and do the other things, not because they are easy, but because they are hard, because that goal will serve to organize and measure the best of our energies and skills, because the challenge is one that we are willing to accept, one we are unwilling to postpone, and one which we intend to win, and others, too." "For the eyes of the world now investigate space, to the moon and to the planets beyond, and we have vowed that we shall not see it governed by a hostile flag of conquest, but by a banner of freedom and peace," the president told 40,000 people in Rice's football stadium that day. "We have vowed that we shall not see space filled with weapons of mass destruction, but with instruments of knowledge and understanding."

Ballots will be sent out by March 25, to Maryland Federation of NARFE members by the NARFE Email System (NES) and paper ballots by postal mail to those members who requested a paper ballot. Voting begins March 26. Voting ends/ballots must be postmarked by April 15. Ballot and Teller Committee count of votes is due on April 30. President Dr. Roundtree will announce the results of the voting on May 1. For the Maryland Federation members and National Only members in Maryland who do not have an email address, you will need to request a paper ballot be sent to you for voting. After eight years of working both sides of the aisle through years of sequestration and other assaults, and tirelessly defending our earned benefits, federal retirees have lost nothing! Please pledge to continue sending your letters, making calls, and meeting our Lawmakers in person and nurturing them, because we are witnessing the resounding impact you have generated.

Our National Legislative Conference culminates in our Maryland Federation's Crusade to Capitol Hill on March 13. Our Lawmakers plan to drop in as we meet with their Legislative Directors in their Capitol Hill offices. Your Senate & Congressional District Leaders (CDLs) and officers listed below will lead the March 13 meetings with Lawmakers: **Senators**— **Van Hollen**-2:30 p.m. **Cardin**-3 p.m.-**Dr. Bruce Fowler**; **Congressmen**: **Cummings**-10 a.m.-**Dr. Gary Roundtree Sr**; **Raskin**-11 a.m.-**Kathy Siggins**; **Ruppersberger**-11 a.m.-**Ron Bowers**; **Brown**-11:30 a.m.-**Edward Holland**; **Sarbanes**-1 p.m.-**Chuck Thomas**; **Harris**-2 p.m. **Evelyn Kirby**; Majority Leader Hoyer-4 p.m.-**Dr. Sudha Haley**; and **Trone**-4 p.m.-**Ed Reed**. We will be delivering our stories to our Lawmakers, through our 2019 Golden Edition *Profiles in Civil Service*. In addition to NARFE Maryland, this year the Profiles include **NARFE's Virginia, Pennsylvania and District of Columbia Federation members' profiles**. Kudos to our Federation Secretary **Patricia Farmer** who edited ALL jurisdiction's profiles. And, special acclaim goes to our Graphics Director **Ted Page** for the outstanding Profile covers and Golden Edition Profiles' preparation for publication.

Your Federation officers are already involved, through grassroots action, in NARFE's priorities in the **116th Congress** to: Improve integrity of the Federal Long-Term Care Insurance Program; Ensure Postal retirees don't pay for Postal Reform; Provide FERS retirees with full COLAs; Calculate COLAs on the CPI-E; and Prevent unilateral government reorganization. The Proposals we are targeting for defeat are to: Eliminate or Reduce COLAs; Increase FERS retirement contributions by 6 percent; Eliminate the FERS Annuity Supplement; High-3 to High-5 for future retirees; Reduce Rate of Return on the G Fund; Reduce Total Paid Time Off; and Freeze Federal Pay.

All our efforts on Capitol Hill need your support through the **NARFE-PAC**. This is the month we are highlighting our Federation's involvement in this political action committee, where your donations help us elect members of Congress who support our federal community. STATE LEGISLATIVE COMMITTEE (SLC) REPORT

There is quite a bit of difference between a substantive plan and the usual political sound bites. A campaign promise, such as a "wall" for example, is usually not much more than a sound bite. On the other hand, a fully developed plan ordinarily includes a methodology for implementation and follow up and is specific as to identifying roles and responsibilities. Most of all a fully developed plan makes it clear as to the issues being addressed and the goal to be achieved.

That, my NARFE cohorts, is exactly what we did to address the injustice of the federal tax plan on the middle-class taxpayers of Maryland, a tax plan that served more as a campaign promise to the top one percent of income than an actual plan to relieve the tax burden on the middle class.

A fully developed plan is exactly how we moved forward to hold the collective feet of our state legislators to the fire for neglecting to address the injustice of the federal tax plan a full year earlier.

The first and most critical element of the plan was to establish a clear goal. Our goal was to have our elected officials in the state legislature enact legislation that would allow itemized deductions on state returns even if the Maryland taxpayer chose the standard deduction on the federal return. This was a critical step in mitigating the impact of the federal plan on Maryland taxpayers since current law does not allow such decoupling and requires taking the minuscule state standard deduction if the now increased federal standard deduction is taken.

Last year the state legislature chose not to address this needed fix, using the excuse that it was "too soon" to assess the full impact of the federal tax plan. A year of ignoring the issue did not seem to bring the state any closer to addressing the issue. The estimated impact on middle class Maryland taxpayers who had ordinarily itemized deductions in the past was an average of around \$1,000 additional state tax. Not something to be easily ignored.

The Comptroller's office estimates that the changes to the State personal income tax as a result of the federal tax plan will result in net additional state revenues of \$403.9 million in fiscal 2019 and another \$315.9 million in fiscal 2020. That is not money in the Maryland budget. That is money that found its way into the Maryland coffers as an unintended consequence of the federal tax-plan. That is tax money that would have been due Maryland taxpayers if not for that federal tax plan. That is Maryland taxpayer money.

The next element of the plan, then, was to make sure that state legislators were made aware of this injustice AND that Maryland middle class taxpayers would not stand idly by as state legislators found new avenues to spend that windfall.

Accordingly, the State Legislation Committee of the Maryland Federation of NARFE actively pursued outreach efforts

to meet with as many state legislators as we could to ensure that they were made aware of the injustice and that we expected them to support our efforts to correct that injustice. This included reaching out to both Democrats and Republicans to ensure that the issue was viewed as nonpartisan and that the solution needed to be nonpartisan if it was to succeed.

A formal survey on the issue was widely distributed to all candidates running for the state legislature as a means of documenting their positions on the issue.

Even more important, the State Legislation Committee mobilized NARFE membership to raise their collective voices to ensure that state representatives understood the gravity of this issue and its importance to their constituents. The electronic tool developed for and provided to NARFE members to contact their state legislators was widely used and extremely effective. The word did, indeed, get out.

I am also proud to say that these collective efforts did succeed in sponsorship of bills in both the House of Delegates and the State Senate to address the need to decouple the state return from the federal return. House Bill 327 and Senate Bill 906 are the direct result of the NARFE implementation plan of which I speak.

It is still too early to claim complete victory since, at the time of this writing, the two bills have not yet made it out of either the House Ways & Means Committee or the Senate Budget & Taxation Committee. Regardless, however, I can say with absolute certainty that without this coordinated effort, this detailed implementation plan, there would have been no chance at all of the state legislature addressing this problem and willingly sacrifice the additional revenue they would have been more than happy to spend.

Stay tuned for further developments and continue to make your voices heard.

MEMBERSHIP REPORT

This MEMBERSHIP REPORT is taken from a 2008 - NARFE "Membership Development Manual." But, its words are so very important today. Our THEME: "Together We Can" is: Our Commitment to Membership Throughout the Chapter.

(1) A commitment to membership must be demonstrated by chapter leaders, even those not directly responsible for membership. Chapter leaders promote the success of member participation by their commitment to membership development. At the chapter level, Membership Goals are set by chapter officers who delegate responsibility to the entire membership.

(1a) NARFE chapters are the sum total of its members. Each member contributes to and influences the Group dynamics. In Membership Development, there are many roles for people to play. People feel a sense of accomplishment when they know what they are doing will make a difference. Membership Development offers many opportunities for participation. At least one person in each chapter, regardless of resources, should be accountable for Membership Development. Ideally, many members will be involved, thus reducing the workload and increasing participation within the local chapter and providing training for future Membership Chairs and Chapter Leaders!

(2) Use NARFE Meetings to Promote Membership: Promote Membership Development during the monthly meeting. Provide time to introduce new members and guests. Recognize new members, recruiters of new members and discuss incentives to participate in Membership Development activities. No matter how large or small the attendance, devote some time during the meeting to Membership.

(3) Develop a Written Plan for Membership: Write an Annual Plan with defined goals to attract new members, satisfy the needs of existing members, train members in Membership Development and promote the aims of the MD Federation and National NARFE. Remember the letters "KISMIF" - Keep It Simple, Make It Fun! Determine how much money can be spent in support of recruitment. Keep in mind that chapter funds are also needed to support retention activities. "Ten Percent" funds can be used for Membership Recruitment and Retention Activities.

(4) Use Your Newsletter to Promote Membership: Include a list of new members, successful recruiters or members opting for dues withholding. If a chapter is losing members, advise members that work is needed to reverse a downward trend.

(5) Display Membership Services and Literature Attractively at Meetings: Display available recruitment literature, point out what's new, and encourage members to take literature and applications with them. Bring applications to monthly meetings and print an application in your newsletter. Point out that every issue of *narfe* magazine carries applications.

(6) Leadership Strategies: The more people involved in recruitment, the better the result. All reading this are well aware of the problems in recruiting volunteers to meet chapter leadership needs. It is a serious problem for many chapters to find members willing to take officer and committee assignments. That is why we stress the attention should be lavished on new members.

In conclusion: - Membership Goals and People: Purpose and Goals of the Membership: - Develop a Recruitment and Retention Plan, which identifies and promotes the benefits of membership. Develop among all chapter members the sense of responsibility and commitment to: Membership Growth, Development and Participation. With the support of your chapter's leadership, many goals are achievable and are most important to the future of your chapter; it could just be New Members, New Members-Per-Month, Increase the Number of Members Participating in all Membership Development, Increase the Number of NARFE Spouse Members by two, Increase the Number of Member Renewals or Increase the Number of Members who participate in Dues Withholding Program by 10 Percent -- ALL Are Reasonable Chapter Membership Goals! Good Luck to All!

Resolution on NARFE Support for Social Security Legislation

The Social Security trust fund is projected to have a deficit in 2034 or so, such that it will not have enough revenue coming in to pay for all the benefits due to Social Security recipients. Representative John Larson, (D-CT), Chair of the House Ways and Means Committee, Subcommittee on Social Security, has introduced the Social Security 2100 Act (H.R. 850) with more than 200 cosponsors, to fix the problem and do even more. (All of Maryland's seven Democratic representatives are cosponsors.) As of the end of January, it had eleven endorsers, including for example, AFL-CIO, AFGE, NCPSSM, Senior Citizens League, and Social Security Works. In the last Congress, the bill was cross-filed and sponsored by Sen. Blumenthal (D-CT) and Sen. Van Hollen (D-MD).Note that NARFE is <u>not</u> one of the endorsers. This is because NARFE's Legislative Program for the 116th Congress, while having several worthy legislative goals for Social Security, lacks the broader goals of reducing the deficit in the Trust Fund and improving benefits. Western Montgomery County Chapter 258 has submitted such a resolution to NARFE HQ for action, as authorized in the Bylaws. The resolution is very simple. It states: "**NARFE will support legislation regarding Social Security that improves the solvency of the trust fund and increases benefits for all beneficiaries."**

Rep. Larson's bill would reduce the deficit in the Social Security trust fund in two ways. It would tax earned income above \$400,000 and it would increase the joint employee-employer FICA tax by 0.1 percent annually for 20 years. Problem solved. NARFE already supports legislation to raise the Wage cap above its current level of \$132,900 but not the gradual increase in revenues. The additional revenues would be used, in part, by increasing Social Security benefits for all current and future beneficiaries by about two percent, by changing the COLA calculation to one based on the higher expenses of elderly retirees (CPI-E), by increasing benefits for caregivers and others who are not able to be in the workforce for 30 years, and by other means. 1. GET YOUR PERSONALIZED TSP BENEFIT ANALYSIS and FEDWEEK HANDBOOK: All Active Federal Employees are eligible to receive free, no obligation Federal and TSP Benefit Analysis along with a free FEDweek Publication of their choice.

2. As of January 31, 2019, the NARFE Alzheimer's fundraising total is \$13,012,034.73. We are so thankful for all the support and sharing our vision of a world without Alzheimer's.

3. March is NARFE-PAC month, so make sure you contribute to the fine work of FED-friendly candidates who compete in elections, which sets the stage for a more receptive audience on Capitol Hill. That is a big first step toward protecting your earned pay and benefits.

4. It is critical that NARFE enter its second century strong, relevant and firmly established as the go-to resource for our members and prospective members, in the federal community, policy makers, the media and the public. NARFE must aggressively market itself to currently employed, prospective members with a brand that meets their needs and expectations.

5. Just a Reminder: Don't forget to sign up for LEGcon19 - NARFE's Legislative Training Conference March 10-13, 2019, at the Hilton Mark Center, Alexandria VA. NARFE's Day on the Hill will conclude with a closing reception; attendees will have the opportunity to mingle with Members of Congress and their staff.

6. FEEA gave out 412 NARFE Shutdown grants of \$100.00 each for a total of \$41,200 + 25% recovery of admin costs = \$10,300 or a total of \$51,500.

7. The NEB extended the \$10.00 Recruitment Incentive for another two years, after which the NEB will evaluate the effectiveness. Many Federations continue to give the incentives as well.

8. Access to "National - Only Members": Access is now granted to the files of National Only Members by Federation Presidents, National Legislative Chairs, Congressional District Liaisons, Senatorial Legislative Liaisons, Federation Membership Chairs and District/Area Vice Presidents.

9. Four Special Standing Committees were created:

- a. Centennial Committee NARFE will be a 100-year old association in 2021. A Centennial Committee was formed to investigate options to include the celebration with FEDcon21.
- b. NARFE HQ Building This committee will investigate potential options for the HQ Building with regard to use or sale of the NARFE building.
- c. Membership Committee This committee was formed to help reduce the number of lost members each month.
- d. Non-Dues Revenue This committee will explore options and opportunities for NARFE to increase revenue from sources other than dues.

Treasurer's Report and Approved Budget for 2019

Federation Finances as of December 31, 2018.

At the start of 2018, the Maryland Federation's net assets totaled \$102,042. As of December 31, 2018, they totaled \$98,101 for **a year-to-date deficit of \$3,941**. The most significant revenues came from ten-percent funds (\$50,660). See detailed summary in table below.

Net Assets as of December 31, 2018. The Federation's net assets included: B of A Checking - \$1,512.40 and B of A Savings - \$96,589.03. Net assets total \$98,101.43 (inFirst FCU account was closed in January 2018 and assets transferred to B of A Savings. The B of A certificate of deposit matured on April 5, 2018 and assets were transferred to B of A Savings.) **Approved Budget for 2019.** The 10 percent revenue is projected to fall as membership declines slowly. The per capita fee for 2019 was waived.

Resolution from Our Federation

Saj Durrani and John Stackpole Co-Chairs, Resolutions Committee

The Resolutions Committee (ResCom) received only one Resolution before the Federation Board's February meeting. It suggests a change in the text of future ballots by HQ for changes to the National Bylaws, and was submitted by Sarah Richards, a member of our ResCom and President of Chapter 1892 – Aspen Hill. Please see Sarah's article below for details of the Resolution.

The ResCom recommended adoption of the Resolution, and the Board agreed, so it has been submitted to Headquarters. However, the National Bylaws and Resolutions Committee is still in the process of updating its procedures, and we have not heard back from them.

National NARFE Bylaw Change Proposal

from Sarah Richards, Resolutions Committee

On February 9, the NARFE Maryland Federation Board submitted to NARFE Headquarters a proposal to change the National NARFE Bylaws to include election ballot design standards. The proposal was needed due to the poor design of the last National election ballot. The proposed standards are:

Each ballot shall: (1) be easily understandable by voters; (2) Present all candidates and questions in a fair and nondiscriminatory manner; (3) Permit the voter to easily record a vote on questions and on the voter's choices among candidates; (4) Protect the secrecy of each voter's choices; and (5) Facilitate the accurate tabulation of the choices of the voters.

Headquarters has not yet determined if they will accept this proposal for member review and vote.
