Hello again 1260 members. The 2020 census will begin April 1. Prince George's County has lost thousands of dollars in the past because some residents did not participate or were not counted in the last census. Each person not counted loses the County \$18,000. So, you can see that It is very important that each person residing in Prince George's County be counted in this year's census. There is also a need for census takers who will be paid for their efforts. If interested, contact a census worker for more details.

Chapter 1260's anniversary is April 23. We were chartered April 23, 1973 (47 years young). The Executive Committee has agreed to have a cake and other goodies in celebration of our 47<sup>th</sup> anniversary at our April 16th meeting. The celebration will be immediately after our general meeting.

I have asked the Delegates'-at-Large (Diane and Pearl) to form a Nominating Committee for the purposes of selecting candidates for our April 2020 elections. I'm also asking each member to start thinking of running for one of the elected offices: President, Vice President, Treasurer, Assistant Treasurer, Recording Secretary, and Correspondence Secretary. All offices are open. All non-elected offices will be appointed by the President, with the consent of the Executive Committee. The chapter must have a President and Treasurer to function. If these two positions are not filled the chapter will be terminated. Any volunteers? If no volunteers for these two critical positions, the following will not apply.

**FedCon2020** – August 30 – September 1, 2020. Who wants to go? If the chapter is still in existence, the Chapter will provide \$600.00 plus registration fee to the attendee who goes in place of the Chapter President. FedCon2020 will be in Scottsdale, AZ, at the Westin Kierland Resort and Spa. All other expenses will be on your own. Whoever goes should bring back a summarized report of what went on to enlighten the chapter. Early Bird registration starts February 3 – March 31; members \$165; non-members \$230; Day \$120. Regular registration: April 1 – September 1: members \$190; non-members \$250; Day \$120. On-Site August 30 – September 1: members \$220; non-members \$285; Day \$120.

## **President's Corner continued:**

One of the facts reported at the Maryland Federation board meeting was that Fort Meade (Maryland) is the 2nd largest employer in the state of Maryland with a payroll of over 22 billion per year. And that it is the 5th largest military installation in the United States. Also, our national headquarters (NARFE) is in serious financial problems because of declining membership.

National is currently being audited because of numerous complaints about its financial problems and its inability to send money on a timely basis to NARFE federations and chapters. In spite of the financial problems it may be facing, National will celebrate its 100th birthday with a Gala at the Hyatt Regency on Capitol Hill on June 21, 2020.

NARFE-PAC established ambitious goals for the 2019-2020 election cycle; progress made (in bold):

Raise \$1,750.00: **\$1,043,182.13** 

Grow monthly giving program (sustainer program) by 20%: 17%

NARFE-PAC **Disbursements:** From January through December 2019, NARFE-PAC disbursed \$616,000 for political purposes, including \$336,000 to candidates, \$120,000 to non-candidate committees and \$160,000 to leadership PACs. These numbers show an increase of \$149,500 in disbursements when compared to the fourth quarter of the 2017-2018 cycle, at which time NARFE-PAC disbursed \$366,500.
