State Legislation

Tax unfairness, an important issue that affects Maryland taxpayers, has not disappeared. What has disappeared is any interest on the part of the Maryland State legislature to do anything about it. Remember that, when your state representatives come to solicit your vote. Remember to hold them accountable for not fighting for tax fairness.

Tax fairness, however, is not the only issue that affects YOU. Pharmaceutical pricing is also an issue that affects us all, and addressing the high price of pharmaceuticals is an issue that calls out for our support.

The Maryland Prescription Drug Affordability Board has bi-partisan support and is continuing its work to identify exactly how the high cost of drugs is hurting average Marylanders just like you.

Additionally, it is the NARFE MD Federation's intention to join forces with the Maryland Citizens' Health Initiative and AARP to support legislation that makes an impact on reducing the high price of pharmaceuticals. **You can help** achieve that end by sharing your stories on how the high price of pharmaceuticals directly impacted you. Then type your name, select a sound type if you don't like the default one, and click on the box that says allow microphone and camera. You'll be able to see and hear us, as well as speak should you want. Note: this system **does not work on the Internet Explorer** browser. You will need to use Google Chrome, Safari or any other browser. If you prefer, you can just listen to the audio with any type of phone by calling 301-232-0143 and when asked, key in the pin number 887080 followed by the # sign. You will be connected to the meeting. If you want to test either the videoconference or the teleconference system prior to the meeting, email <u>NARFEsrichards@aol.com</u> and ask for a test.

- October 13 Deadline for registering to vote.
- October 20 Election Board must receive your request for a mail-in ballot by this date.
- October 26 through November 2, 2020, Early Voting takes place.
- November 3 General Election at voting centers and polling places. Note these may be different than those you were previously assigned. You will receive notification of yours in October.

National NARFE Bylaws Change Vote

The National NARFE Bylaws Proposals vote has ended. The Maryland Federation recommendations were followed on 13 of the 22 proposals. However, the MD Federation lost by a small number of votes on our attempt to insert standards for voting ballot development. We also lost our bid to stop an increase in National dues to \$48 and the financial cut to chapters in funds they receive for new members. A proposal to allow the National Executive Board to merge regions without the consent of the merging regions also passed, though we fought against it. Two big wins for us were stopping the cut in funds to Federations and eliminating from the bylaws the detailed job duties of the Executive Director.

MD Federation Bylaws Change Vote

All proposals were approved. We will have clearer bylaws at the MD Federation level now. Thank you for your votes!
