Watch Out!

Fall comes with its own dangers, darkness descending at rush hour, slippery leaves covering the road, lower angle sun creating glare on windshields, deer in mating season running out into the roads. Be careful, note your surrounding dangers, and if a deer runs out in front of you, brake to slow or stop—swerving could hit another vehicle or the deer that jumped that way.

You can easily access the videoconference via computer, tablet, or smart phone. There is <u>no</u> app to download; just click on the link (best way to connect) or type in:

https://live.unlimitedconferencing.com/live/SarahRichards/myconference.

Then type your name, select a sound type if you don't like the default one, and click on the box that says allow microphone and camera. You'll be able to see and hear us, as well as speak.

This system **does not work on the Internet Explorer** browser. You will need to use Google Chrome, Safari or any other browser.

If you prefer, you can participate with audio-only with any type of phone by calling 301-232-0143 and when asked, key in the pin number 887080 followed by the # sign. You will be connected to the meeting.

If you want to test either the videoconference or the teleconference system prior to the meeting, email MARFEsrichards@aol.com and ask for a test. She's happy to help you get online.

NARFE Annual Meeting October 2020

Ken Thomas, President of NARFE, presented some of NARFE's major accomplishments this year at the October National Meeting. One was that NARFE was a contributor in helping to fight the OPM/GSA merger and that NARFE helped write some of the language for the bill to set up a study of OPM rather than merge it with GSA. Then, Kathryn Hemsley, Secretary/Treasurer, presented an update on the state of the finances and work on new bylaws. The third presentation was by the CEO of the Alzheimer's Association who thanked NARFE for its generous contributions and discussed new advances in research like finding blood markers showing both tau and amyloid in lab tests which could lead to faster and easier identification of folks with Alzheimer's disease. He said there are more treatment options now, and that there is a study in Finland that shows you can reduce the risk of Alzheimer's through lifestyle changes.

Schedule F Call to Action and Update

Visit NARFE's Legislative Action Center to urge your lawmakers to block the president's Executive Order (EO) 13957, which will convert tens, or even hundreds of thousands of civil service positions into political appointments. The president's action threatens the integrity of a professional, nonpartisan civil service—a federal standard since the late 1800s.

If fully implemented, this executive order will allow agency heads to move employees into a new Schedule F excepted service designation. Civil service rules ensure federal employees are hired and fired based on their merit, not their political connections or lack thereof. These rules protect employees from being removed for choosing adherence to the Constitution, laws and professional standards over politically motivated actions.

Our country needs a competent, impartial civil service that holds the trust of the American people. Help protect the civil service today by emailing your lawmakers.

In response to the executive order, NARFE National President Ken Thomas issued a letter to Congress asking lawmakers to nullify this order, regardless of the results of the election.

Congressional Democrats sent a letter to the acting director of the Office of Personnel Management (OPM), Michael J. Rigas and requested that OPM "cease any activities related to the implementation of this executive order while the Committee obtains documents and information regarding the development of this policy." The letter contained a portion of NARFE's previously released statement on the matter.

Best Material for Making Your Own Masks

The American Chemical Society published in ACS Nano an article (April 24, 2020) discussing the best material to use for making your own Covid-19 mask. It said, "One layer of a tightly woven cotton sheet combined with two layers of polyesterspandex chiffon—a sheer fabric often used in evening gowns---filtered out the most aerosol particles (80-99%, depending on particle size), with performance close to that of an N95 mask **material.** Substituting the chiffon with natural silk or flannel, or simply using cotton guilt with cottonpolyester batting, produced similar results." The authors of the ACS article acknowledge use of the U.S. Department of Energy's Center for Nanoscale Materials user facility at Argonne National Laboratory and funding from the U.S. Department of Defense's Vannevar Bush Fellowship.
