Maryland Senator Mike Miller died on Jan 14. Delegate Michael Jackson, District 27B, was appointed by Governor Hogan to fill Mike Miller's District 27 Senate seat. House District 27B as well as Senate District 27 cover the northern portion of Calvert County. With Mr. Jackson moving to the Senate, House District 27B is open and is subject to a solicitation by the Calvert County Central Committee. A special hearing, date and time TBD, will be livestreamed on Facebook.

FEDERAL NEWS (from NARFE HQ)

Form 1099-R from OPM

According to OPM, all 2020 1099-R forms are mailed to annuitants by January 31. Mailed 1099-R tax forms may not be received until mid-February, depending on where the annuitant lives. Please keep a close eye on your mail. You may also go to OPM.GOV and download your 1099-R.

FAIR Act Proposes 3.2 Percent Average Federal Pay Raise for 2022

On January 21, Rep. Gerry Connolly, D-VA, reintroduced legislation to increase federal pay and make progress toward closing the gap between public- and private-sector wages.

NARFE Supports Rescind of Schedule F

NARFE National President Ken Thomas issued a statement in support of President Biden's action rescinding the executive order that created a Schedule F federal employment category. On October 21, an Executive Order directed agency heads to identify current federal employees involved in "positions of a confidential, policy-determining, policymaking, or policy-advocating character". All such positions would be moved to a new "Schedule F" position and become essentially "at will" employees who may be fired at any time.

United Seniors of Maryland

In past years the United Seniors of Maryland, MD NARFE, and AARP MD held an annual rally at the beginning of the legislative session in the Senate Office building in Annapolis. They were able to have MD Legislative Leadership and MD Senators and Delegates participate. COVID-19 has caused that rally to be postponed until the 2022 Session.

The impact of the pandemic overshadows all proposed legislation. This year, the USM Group is tracking and supporting legislation impacting seniors. The bills are for Covid-19 protection, testing, vaccines for all seniors; senior estate and tax breaks, budgets for MD Department of Aging and Health and the services they provide, Broad Band access for seniors and Tele-health, Financial Health of Hospitals and Health Services, Housing and Evictions.

They are also tracking things such as Driver Licenses for those over 85, absentee ballots for seniors and the disabled, etc. They are holding weekly action and status meetings via Zoom. NARFE MD Leadership usually participates in those weekly meetings. Greg Stottlemyer will participate in as many as he can.

Computer Fraud

(from the AARP Fraud Watch Newsletter)

"Your computer is infected with a virus". That's a scary statement to suddenly receive, but the scam is not to just sell you unnecessary technical support:

- You get an <u>unsolicited phone call or</u> <u>email</u> from a big tech company like Microsoft or Apple, Big tech companies like Microsoft and Apple don't call customers out of the blue to warn them of problems on their devices.
- or you see <u>a pop-up message</u> on your screen warning that a virus or other malicious program has infected your device, and you need to call the number on the screen right away.
- <u>A "technician" asks for remote access to</u> <u>your device</u>, and once in, shows you some files that "prove" you have a major problem. Be aware: The concerning files the "technician" may show you on your device are completely benign.
- <u>The "technician" says they can fix your</u> problem for a fee, and then may offer you a monthly subscription to keep your device safe.
- <u>The scammer may ask you to pay by</u> <u>purchasing a gift card</u> and providing the account number and PIN — a sure sign that it's a scam, as is a request for payment by wire transfer.
- The scammer may call back months later and <u>offer you a refund for some phony</u> <u>reason</u>, asking for your bank account information to deposit the money.

These are all a ruse to gain access to your devices, cheat you out of money or worse, get access to your financial accounts. Be careful of your online activities!

Medicare Solicitation Fraud

With all the solicitations and TV ads for Medicare Advantage (Medicare Part C) AARP's Fraud Watch is warning people who are contacted by phone about "new and improved benefits from Medicare". <u>The Fraud</u> tipoff is that you didn't initiate the contact:

 You receive a call or home visit from a home health care agency offering to sign you up for services that Medicare will pay for. Anytime you see an ad or get a call offering you something for "free" from Medicare, it is a scam.

- You get a call claiming that Medicare is sending out new "chip-enabled" Medicare cards. Medicare is sticking with the current paper card and is not sending out chip-enabled cards.
- <u>You get a call about a special "deal"</u> on a new Medicare plan during open enrollment. It may come with a free gift or limited-time offer. By law, legitimate Medicare insurance providers will contact you only if you have previously requested information.

File your 2020 Income Tax Returns

Its 'tax time' again! The IRS will not be accepting ANY tax returns until after FEB 12th this year. Due date is April 15th for most filers. Direct Deposit Refunds will be delayed up to two weeks after filing. Paper checks may take a month or more!

The New CARES act applies to businesses and the self employed who were out of work due to COVID issues. Stimulus payments for sick leave while caring for self or other individuals or for day care can be claimed on the 2020 tax return.

The rebate Recovery Act applies to everyone. In 2020 you should have received payments for self, spouse and any children. Since January 2021, additional checks where sent out and Congress is considering an increased amount, yet to be determined. They were based on social security entitlements and filing of 2019 tax returns.

Don't worry if you have not seen these EIP payments. You will be able to claim ALL unreceived payments on your 2020 tax return. They will be added into your refund amount and be paid regardless of any other government indebtedness.

Actual tax filing suffered last year due to closures and illness due to COVID, Expect the same problems in 2020. There are several online free filing venues if you can do it yourself. The **IRS FREE-FILE** has limits on income and deductions above \$72,000 AGI and has fillable forms for download. See IRS.GOV. Maryland also has online free file. AARP will again offer its **TAXAIDE** program in local areas and an **ATP**, Alternative Tax Prep service using (limited) commercial software (Turbo-Tax, TaxSlayer) for self-filing with telephone assistance.

Maryland State Taxes –

Are you angry yet? Well if you are a Maryland taxpayer who ordinarily had itemized deductions on your Maryland state tax returns, then you should be! Your elected officials in Annapolis failed to protect you from the tax hike imposed on your 2018 and 2019 and 2020 state income taxes resulting from the federal tax plan. This un-legislated, unapproved tax hike cost Maryland taxpayers an estimated \$500,000,000 each year.

Last year, there were bills that called for decoupling state deductions from federal deductions that never made it out of committee.

HB 327 is a critical bill that must be supported in that it takes the major step of decoupling the state return from the federal return thereby allowing itemization at the state level even if the standard deduction is taken at the federal level. This is a critical step in the ongoing effort to, as Governor Hogan described it, "make us whole."

How do you make your concerns raised to your legislators? Google "MD NARFE", click on the "Maryland Federation of NARFE" and then click on "Legislative - State Page" in the upper right-hand corner. You will then have access to "What you can do about it." <u>Click here</u> This link will enable you to directly contact your elected officials in Annapolis, as well as provide you with a sample letter that can be used in the process. Go for it! The money you save will be your own.
