#### Pandemic, Ethics Early Biden Priorities; Concerns Grow on Implementing Schedule F Last Minute

National Guard members patrol as military units march on the East Front of the Capitol during an inauguration rehearsal outside the Capitol. House leaders have urged OPM not to carry out the Schedule F order saying it would only lead to protracted legal battles and waste resources to reverse it.

With the presidential transition now immediately at hand, the incoming Biden administration has described its intention for early steps on the pandemic and ethical issues inside the government, amid concerns about potential last-minute actions by the outgoing Trump administration to carry out its controversial "Schedule F" executive order.

The pandemic in general will be among the new administrations' top priorities, with emphasis growing the amount of available vaccine and greatly increasing the rate of inoculations. That could indirectly benefit federal employees who in occupations deemed high priority but who still have not received inoculations, either directly from their agencies or along with those of similar priority in the general population.


