Let's make the most of his visit! Be sure to participate **May 25th at 1:00 PM** via videoconference or just regular phone teleconference. We have invited Wheaton/Glenmont, Rockville, and Leisure World Chapters to share this event with us.

The system will be accessible at 12:45 PM to allow folks to comfortably get online. Lines will be open for chatting during that period, too. You can easily access the meeting via the Zoom-<u>like</u> Videoconference system by computer, tablet, or smart phone. There is <u>no</u> app to download; **just click on the link** (best way to connect) or type in: <a href="https://live.unlimitedconferencing.com/live/SarahRichards/myconference">https://live.unlimitedconferencing.com/live/SarahRichards/myconference</a>.

Then type your name (first and last), select a sound type (may have to do that in two boxes if you don't like the default one or if the sound does not work). Then click on the box that says allow microphone and camera. You'll be able to see and hear us, as well as speak.

This system **does not work on the Internet Explorer** browser. You will need to use Google Chrome, Microsoft Edge, Safari or any other browser.

If you prefer, you can participate with audioonly using any type of phone by calling 301-232-0143 and when asked, key in the pin number 887080 followed by the # sign. You will be connected to the meeting.

Note: Since this is a multi-chapter meeting, it's your opportunity to say hello to folks you haven't seen in a while.

#### Don't Forget--Repeal WEP and GPO!

The Social Security Fairness Act, H.R. 82, was introduced by Representative Rodney Davis, R-IL, on January 4. The bill would repeal both the unfair Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO). WEP and GPO limit some Federal retirees from receiving all of the Social Security they earned. # New Bipartisan Caucus to Fight for TAX RELIEF for Middle Class Families

Congressman Jamie Raskin (MD-8) joined with other U.S. Representatives to announce the formation of the new <u>bipartisan</u> SALT Caucus that will advocate for new tax relief.

"We're formally launching a new bipartisan group — the SALT Caucus — because, for all our Members, and for the tens of thousands of middleclass families we represent, it is high time that Congress reinstates the State and Local Tax deduction, so we can get more dollars back in to the pockets of so many struggling families especially as we recover from the pandemic," said Rep. Josh Gottheimer, SALT Caucus Co-Chair. "This bipartisan group we're founding today, with members from coast to coast and across the political spectrum, are all banding together to reinstate the State and Local Tax deduction, to find a way to get this done in Congress, and to actually get tax relief for the working middle-class families we represent." "Our effort to restore the SALT deduction is gaining momentum. Together, Democrats and Republicans alike, we will advocate for the restoration of the SALT deduction and highlight the middle-class families who have been unfairly hurt by the cap," said Rep. Tom Suozzi, SALT Caucus Co-Chair. "

"Half of all taxpayers in Maryland's 8th District benefit from the SALT deduction, with the average deduction reaching approximately \$19,000," said Rep. Raskin, SALT Caucus Vice Chair. "The \$10,000 cap imposed by the 2017 tax law has short-changed hardworking middle-class families. I'm proud to launch the bipartisan SALT Caucus to repeal the deduction cap."

# Understanding Insurance to Protect You and Your Property

Kejuana Walton, Outreach Staffer for the Consumer Education and Advocacy Unit, Maryland Insurance Administration, gave a presentation at our April meeting. She noted that the Maryland Insurance Administration (MIA) is a state agency regulating insurance in Maryland, licensing insurance companies and agents under Maryland law as well as monitoring insurance company policies, reviewing rates, and investigating consumer complaints and fraud. MIA services are free (800-492-6116; <a href="www.insurance.maryland.gov">www.insurance.maryland.gov</a>).

During her talk, she displayed 89 PowerPoint slides. The slides contain a wealth of information about automobile, home, renter's, and life insurance. Check the PowerPoint presentation for expanded information, insurance definitions, specifics, and examples of MIA insurance cost guides. Request the slides at NARFEsrichards@aol.com.

She also discussed Insurance Fraud. A higher incidence of fraud involves automobile insurance, but fraud is found with: arson, inappropriate insurance sales practices, unnecessary medical tests, fake accidents and repairs, excessive billing, as well as scams involving Workers Comp, Social Security, and the IRS. You can reduce fraud by reviewing and understanding all insurance-related documents; making no on-the-spot decisions; keeping records and notes regarding insurance transactions; exercising caution when using the internet for insurance services; paying only by check or credit card; requesting evidence of licensing, liability insurance, etc., when employing contractors and taking photographs of work performed.
