Legislation Report

LEGISLATION: Since ADVOCACY is one of NARFE's Primary Activities for ALL it's **Members,** I have prepared a Composite of current NARFE Legislative Information this month! NARFE's Advocacy Refocuses as Members of Congress have returned to Capitol Hill. NARFE's advocacy team is looking toward Congress' pushing forward with its legislative priorities. The House broke its summer recess and returned to Capitol Hill to further negotiations on the fiscal year 2022 (FY22) budget. The House Committee on Oversight and Reform furthered its role in the budget reconciliation process, voting favorably to implement the instructions provided to the committee by **S.Con.Res.14**, the Concurrent Resolution on the Budget for FY22. The resolution provides instructions to the committees on how to proceed with the budget framework. Congress will incorporate the Committees' policies into a reconciliation bill, which both chambers will then consider. * What's in the bill? The legislation would provide \$12 billion to GSA and USPS to electrify vehicles, build charging stations and enhance infrastructure. One billion dollars would go to the Technology Modernization Fund to modernize high priority systems. Two billion would go to the Federal Citizen Services Fund to improve federal cyber security and delivery of critical services. Information technology oversight and reform initiatives at the Office of Management and Budget are slated for \$350 million. * In August, 13 Representatives joined the list of cosponsors of the Social Security Fairness Act of 2021, **H.R. 82**, legislation to fully repeal the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO). It is not a coincidence that 13 additional Representatives signed on as cosponsors, but rather a direct result of NARFE Members' hard work. WEP reform legislation, the Public Servants Protection and Service Act, H.R. 2337, didn't gain as much traction, adding only one additional cosponsor during the recess. * As you know, NARFE supports both repeal and reform bills because they would provide much-needed financial relief to retirees affected. ALL NARFE Members are encouraged to continue their advocacy to increase the number of cosponsors to 290, which would force a vote by the full chamber.

* **Stay Informed and Engaged:** Do you know if your lawmaker is a cosponsor of NARFE-supported legislation or is supporting legislation that can negatively affect active and retired Feds? **Visit** <u>http://www.congress.gov</u> and enter the bill number to find out. COVID-19 MISINFORMATION

There are over one hundred million eligible citizens who have not or will not be vaccinated against COVID-19. Many of these people have legitimate reasons not to be vaccinated. On the other hand, many have found misinformation on social media, TV, and in newspaper articles. There are 10 prominent types of misinformation about COVID-19 vaccines as follows –

The Covid-19 Vaccines Do Not Work - Clinical trials and real-world studies proved that the vaccines are safe and effective at protecting against infections and severe symptoms.

Were Not Properly Tested or Developed - The U.S. allowed emergency use of three different vaccines after clinical trials involving tens of thousands of participants showed they were safe and effective.

Are Mandatory - Some colleges and businesses require vaccinations as a condition of entrance or employment. Businesses are not barred by health information privacy laws from asking customers about vaccinations.

Vaccines Contain Microchips for Government Tracking Us - This is not physically possible. As Dr. Paul Offit, chair of vaccinology at the University of Pennsylvania's Perelman School of Medicine pointed out: "A microchip is about 0.5 inches long. That wouldn't fit through the end of a needle."

Contain Metals and Other Problematic Ingredients - The makeup of the vaccines available in the U.S. is no secret.

Ingredient lists for the Pfizer, Moderna and Johnson & Johnson shots can all be found online.

Have Caused Widespread Death and Disease - The vaccines are known to cause some temporary side effects, such as fatigue. The Centers for Disease Control and Prevention (CDC) wrote as of July 21 that, based on its review all information for death reports in the database, there remains no "causal link" to the vaccines.

Stunt Fertility and Disrupt Pregnancies - As CDC recently stated, "There is currently no evidence that COVID-19 vaccinations cause any problems with pregnancy, including the development of the placenta. In addition, there is no evidence that female or male fertility problems are a side effect of any vaccine."

Can "Shed" To Affect Unvaccinated People - The vaccines do not "shed" to affect unvaccinated people. In fact, that is biologically impossible. Such shedding can only occur with vaccines that use weakened forms of the virus, according to the CDC. But none of the COVID-19 shots are live-virus vaccines.

Alter Your DNA - The available vaccines use different technologies to instruct cells to build protection against the virus. According to the CDC, no genetic materials enter the part of the cell that hosts DNA.

Killed or Harmed Various Celebrities - Those claims have not been substantiated.

If you have not been vaccinated, read and listen to all you can. This is not a matter of just you - it is a matter of family, friends and your neighbors. This is about reality and survival. There have been 621,000 deaths due to the COVID
