The check must arrive no later than June 1, in order for us to purchase the food, etc.

The \$15 covers the shelter rental as well as food and other products, so food donations of your special dishes to add variety to the fare are welcome, but not required, for sure.

Wheaton Regional Park is located at 2000 Shorefield Rd., Silver Spring (Wheaton), MD 20902. Shorefield Rd. is off Georgia Avenue. To get to Picnic Shelter "G", take Shorefield Rd. till it dead ends in a circle. As you enter the circle, you take the first right turn down the road to a large parking lot toward the carousel. The first Picnic shelter sidewalk off the parking lot leads to Picnic Shelter "G". You'll be able to see us from the parking lot. There is plenty of parking and four handicap spaces near the Shelter.

This shelter was chosen to accommodate walkers and wheelchairs. Picnic Shelter "G" is only 30 feet from the parking lot on level ground with no steps to traverse. Restrooms are nearby with no steps to traverse. Shelter "G" is not far from the train station should folks want to take a ride on the train.
