

Secretary's Report for May 2022 Newsletter

In the absence of President Pat Nix, Vice President Ed Reed presided at today's meeting. He welcomed 17 members and our Guest Speaker, Kim Torsiello, and reminded us of other areas to be discussed during our meeting: 50/50 drawing, Alzheimer's Donation Can, Special Raffle Tickets available. Members were thanked for contributing canned goods which will be taken to the Commission on Aging for the Meals on Wheels program. A final reminder: Please Remember Your Waitress!!

Ed asked all to join in the Pledge of Allegiance and Chaplain Randy Burns offered the blessing. A good lunch was then enjoyed by all.

Our Guest Speaker was Kim Torsiello, R.N. from the Washington County Commission on Aging who spoke on Living Well With Diabetes. Some areas she highlighted included (a) serving size vs. portion size; (b) fiber does not raise carb level; (c) WATCH YOUR CARBS! (d) goals; (e) exercise. The first paragraph of Kim's handout, titled Living Well With Diabetes, said: you don't get really good at dealing with diabetes overnight. But over time, you'll figure out how to go from getting it done to taking it in stride. Remember: Being active most days is a pro move for managing diabetes.

Legislation Report

This month's article is taken from: MD NARFE Chapters - 1892/Rockville -&- 1466/Calvert County's - April Newsletters ** The writers do an Excellent Job of "Highlighting" - The successful efforts our MD NARFE - State Legislative Committee (SLC) has accomplished in the recent Maryland State Congressional Session in Annapolis, Maryland! ** Congratulations! Your letters to state senators and delegates and Paul Schwartz' (Our MD SLC-Chairman) testimony multiple times on the bills for years, finally moved our legislators to pass a bill that Governor Hogan signed that eliminates state taxes for people on Social Security or non-working folks 65 or older that make less than \$100,000 a year. ** The law will be phased in over several years. ** The historic bipartisan agreement to provide \$1.86 billion in tax relief over five years (FY23-Fy27) for Maryland retirees, small businesses, and low-income families. ** Mr. Swartz noted: "That the NARFE (SLC) has been fighting, yes fighting, for several years to bring tax fairness to Marylanders, especially seniors/retirees". ** Regarding "Senior-Migration" to other tax-friendly states, the SLC has lobbied our state legislators incessantly to raise their awareness of the loss to Maryland if they did not stem the tide of senior migration. ** This is certainly not all that the SLC had hoped for, but it is a significant step in the right direction and provides a foundation on which the SLC can build in future years. It is a victory for NARFE advocacy, and the entire SLC are very proud that their efforts contributed to finally seeing some tax relief for our often-ignored senior population in Maryland. **
