TREASURER'S REPORT

Larry Lange, Chapter 258 Treasurer

My last Treasurer's Report appeared in the September/ October 2023 issue of **The BUZZ**. This report will be a synopsis of our Chapter's funds from August 4, 2023 to October 13, 2023:

Chapter 258, Funds Summary, October 13, 2023

Checking account balance, 8/4/2023	\$7,068.67
Receipts, 8/4/2023 - 10/13/2023	\$4,243.62
Expenses, 8/4/2023 - 10/13/2023	\$1,553.71
Checking account balance, 10/13/2023	\$9,758.58
Working Capital/Total Chapter assets	\$9,758.58

The *receipts* for this period were the direct deposit into our Chapter's checking account by National NARFE of the July, 2023 members' dues (\$236.88), August, 2023 members' dues (\$273.86), and the September, 2023 members' dues (\$206.88), plus the payment by attendees of their meals at Alfio's for our September 8, 2023 Chapter meeting (\$390.00), the payment by attendees of their meals at Alfio's for our October 13, 2023 meeting (\$420.00), and the reimbursement by Alfio's for the payment by our Chapter to the tax and tip on meeting meals (for the months of December 2021 through May 2023) (\$2,716.00) for a total of \$4,243.62.

The *expenses* for this period were the printing and mailing of the Sept/Oct, 2023 BUZZ (\$534.83), postage for mailing the Sept/Oct, 2023 BUZZ (\$89.08), and the bill for the attendees' meals at Alfio's for our September 8, 2023 Chapter membership meeting lunches (\$604.80), the bill for attendees' meals at Alfio's for our October 13, 2023 Chapter membership meeting lunches (\$313.00), and a \$12.00 charge for a returned check of Alfio's for reimbursement for tax and tip on meeting meals (for the months of December 2021 through May 2023) for a total of \$1,553.71.

For our Chapter 258 members who are enrolled in the FLT-CIP, they should have received a letter from that program advising of what their increased monthly premiums will be in 2024. As that letter advised, if one is going to make any changes in their coverage under this program, the date such changes must be made is November 9th. On September 26th, National NARFE had a webinar regarding these increased premiums. I watched this webinar and found it to be very helpful. This webinar has been archived on the National NARFE homepage. Here are the steps to access it: sign in as a NARFE member with your E-mail and password; go to the NARFE homepage, and scroll to the bottom of the page; click on "Watch Webinars on Demand"; click on "Find Out More"; the first webinar listed wil be "FLTCIP Enrollee Decision Period - What to Consider." Questions asked when the speakers were finished their presentations included what about NARFE members who are living in a CCRC (Continuing Care Retirement Center).
