## HOW NARFE CAN SUPPORT GOVERNMENT GRASSROOTS CAUSES

- 1. Effort to Prevent the Return of Schedule F Schedule F positions deemed "policy advisory" would have essentially become political appointees, removing job protections for upwards of 50,000 federal employees.
- 2. Fair Act -- provides for an average 7.4 % pay raise for the federal workforce in 2025.
- Federal Retirement Fairness
   Act allows FERS employees to buy back years served as temporary employees toward credit for their retirement.
- GPO/WEP Repeal The effort to repeal the Government Pension Offset and Windfall Elimination Provision has made extraordinary progress.
- Bipartisan Hiring reduces unnecessary burdens to job hiring and would make hiring more efficient and effective.
