State Legislation

With the results of the 2024 election, we must now consider a look at the impact of those results on our legislative priorities. The federal tax plan of 2017 will expire at the end of 2025 but now it will be more likely to be extended in some manner. That will bring back the need, once again, for our support of decoupling the Maryland state tax returns from the federal tax returns, to enable Maryland taxpayers to choose between itemizing on their state returns or taking the state standard deduction.

Another issue concerns controlling pharmaceutical pricing. With the new administration in Washington, the influence of pharmaceutical companies over pricing will likely be increased and should not be ignored. This makes it all the more critical to expand the authority and oversight of Maryland's Prescription Drug Affordability Board, regarding pharmaceutical pricing in Maryland. We will continue our support for this important initiative.

The efforts in Congress to finally repeal the Windfall Elimination Provision (WEP) and the Government Provision Offset (GPO) may also be impacted, with the new administration and the change in control of the senate. We will continue to monitor this situation and how it might impact these efforts. Stay tuned.

The Potomac, a History of the River and the Land

The Potomac River was the first interstate waterway in North America, the spawning ground for the Constitution, and a protective barrier in the Civil War. A dominant geological feature of Montgomery County, to travelers today, the river is a time tunnel to 250 million years of history. Jim Johnston, our speaker at the November 19th meeting, will regale you with this enlightening history, and the next time you walk along the river, you'll see the Potomac in a new way!

Health Insurance Panel Briefing

Five companies offering health benefit plans to active and retired federal employees sent representatives to this meeting. Each spokesperson made brief remarks (five to ten minutes) about respective plan benefits, some changes for 2025, and responses to Office of Personnel Management (OPM) initiatives. All representatives generally commented on how comprehensive the federal health benefits program is, especially with many choices offered. A key point from all was the reminder of open season dates - November 14 to December 9 - for choosing a plan. Their remarks additionally included references to the new Postal Service Health Benefits plans now part of the federal plans. Medicare Parts A and B, Medicare Advantage, and Medicare Prescription Drug Program. Each representative devoted some remarks on better or distinguishing aspects of a carrier plan offered for 2025, as well as to improvements to meet customer needs.

In addition to distributing carrier brochures, summary sheets, and other descriptive literature, each representative provided contact information for fielding questions about plan coverage, as it may relate to an individual's specific needs. Carrier representatives also offered general advice. They urged reviewing as much information as possible to become good consumers when selecting a plan. Make comparisons carefully, advocate for yourself, and evaluate what you expect to need in the coming year. Are you getting the best deal? What is important to you?

The health benefits meeting included a questionand-answer session. Examples of questions reflect many concerns and interests: What is carrier coverage when out of area, including travel abroad? What is the history of Medicare Advantage plans? How are companies addressing cybersecurity? How does premium reimbursement work? What is the Maryland hospital network?
