As we welcome the new administration to the White House, the work of NARFE has never been more vital. NARFE National President William Shackelford stated "Every administration should and will bring along its own cadre of political appointees to set and direct the policy of the duly elected president.

But NARFE will stand firmly against any efforts to eliminate or erode the merit-based civil service, including a reimplementation of Schedule F.

The merit-based civil service protects the honor of the federal government to work on behalf of the American people." NARFE needs the support and voice of the federal workers, retirees and concerned citizens across the country to succeed. Legislative News

On November 12, the Social Security Fairness Act, H.R. 82, passed in the House with an overwhelming bipartisan majority, 327-75. This is a historic achievement in the fight to repeal the Windfall Elimination Provision and Government Pension Offset, two provisions that have unjustly penalized federal retirees and public servants for

nearly 40 years." Senate approval is needed next.

The **Department of Government Efficiency (DOGE)** is a planned presidential advisory commission announced by president-elect Donald Trump. It will be led by the billionaire businessman Elon Musk and entrepreneur Vivek Ramaswamy. Despite its name, it is not expected to be a federal executive department, the formation of which would require the approval of the U.S. Congress. The proposed DOGE has alarmed some government ethics experts who say the deep financial interests of Musk and Ramaswamy could lead to potential conflicts of interest.

2025 Health Insurance Update

The Federal employee's health insurance program is now in open season which will continue until December 9th. During this time, you can make changes to your Health, dental or vision coverage.
