# NARFE'S 2025 MARYLAND STATE LEGISLATIVE PROGRAM

The Maryland Federation of the National Active and Retired Federal Employees (NARFE) represents approximately 300,000 Federal employees and annuitants and the more than 1,000,000 seniors aged 65 and older in Maryland.

#### Goals for 2025

- Tax relief for Maryland's seniors, including but not limited to tax incentives, deductions or credits for long-term care insurance.
- Legislation to reduce the cost of prescription drugs.
- Legislation to help support cognitive and behavioral health issues.
- Protecting senior consumers.
- An increase in the standard homeowner's tax credit.
- Ensuring the availability and quality of medical care in Maryland.

## **Legislative News**

The Social Security Fairness Act (H.R. 82) was signed into law on January 6<sup>th</sup> by President Biden. The result was the

repeal of Windfall Elimination Provision (WEP) and Government Pension Offset (GPO). The WEP was a formula used to adjust Social Security worker benefits for people who receive "non-covered pensions." The GPO caused a reduction of Social Security benefits entitled to public pensions from work not covered by Social Security. This delivered a hardfought victory for public servants across the nation. The legislation, which was passed by the Senate on December 20 and the House on November 12, will ensure that affected Civil Service Retirement System (CSRS) retirees no longer face unfair reductions in their Social Security benefits.

With this landmark legislation now signed into law, public servants who have dedicated their careers to serving the country will no longer face unjust financial penalties, ensuring they receive the full Social Security benefits.
