U.S. ECONOMIC GROWTH TO SLOW IN THE NEXT 30 YEARS

Weak population gains and increased government spending will result in slower overall economic growth over the next 30 years, according to the nonpartisan Congressional Budget Office (CBO).

The CBO's latest long-term budget and economic outlook report — for a

timeframe that spans 2025 to 2055 — projects publicly held debt to reach 156% of gross domestic product, or GDP, in 2055. The mix of slower population growth and unfettered spending will also result in weaker economic growth over the next three decades than what the CBO projected last year. Lower birth rates also mean that the United States is becoming more dependent on immigrants working to sustain growth.

"Without immigration, the U.S. population would begin to shrink in 2033", the CBO report states.
