The Montgomery County Animal Services and Adoption Center (MCASAC) is working to reduce the need for people to surrender their pets due to layoffs by offering families the following support to help keep pets in their homes.

**Pet Food Pantries:** MCASAC has two locations for pet food pantries: the pantry at 7315 Muncaster Mill Rd. in Derwood is available from 9 -10 AM on November 9, 19 and December 3 and 14. The other pantry site is at the Shrine of St. Jude Thaddeus Catholic Church, 12701 Veirs Mill Road in Rockville, available from 7:30 – 8:30 AM. on November 15, 22, and December 6 and 20.

## State Legislation

State Legislation Committee (SLC) Report

In recent years, the Maryland General Assembly has been active in the area of protecting senior consumers from fraud and financial exploitation. During the 2025 session, the State Legislative Committee joined with AARP and other advocacy partners to support several bills to protect senior consumers (although we worked on fewer bills than AARP did with its larger number of volunteers). Here are two of the bills which were enacted into law.

**SB 305 – Financial Institutions and Activities – Virtual Currency Kiosk Registration and Regulations (Senator Pam Beidle, D – Dist. 33, Anne Arundel County, Senator Shelly Hettleman, D – Dist. 11, Baltimore County).**

The legislation, which went into effect July 1, will require the operator of a virtual currency kiosk to register with the state (these registrations will start on January 1, 2026). This Act prohibits virtual currency kiosk operators from accepting or dispensing more than a specified amount of cash or credit in a single day for transactions with a single person (\$2,000 for a new user, and \$10,500 for an experienced user). Additionally, the Act prohibits operators from imposing a fee exceeding the greater of \$5 or 15 percent of the transaction amount, and also requires operators to provide prescribed warnings and disclosures.

The Act further empowers the Commissioner of Financial Regulation to investigate and enforce all regulations under the Act, including consumer protections, reimbursements and disclosure requirements. The Commissioner may impose a civil penalty of up to \$1,000 for each knowing and willful violation. Tony Salazar, the MD Commissioner Financial Regulations within the state Department of Labor, said at a recent AARP conference that the Act should help to decrease the number of scammers, especially when it comes to advanced technology. He noted “despite our collective efforts, the scams [are] not slowing down. They’re actually increasing. There’s a great and urgent need for continued vigilance and education to protect Maryland seniors.”

**SB 347/HB 542 Adult Protective Services - Investigations and Disclosure of Information (Senator Sara Love, D - Dist. 16 Montgomery County/Delegate Charlotte Crutchfield, D - Dist. 19, Montgomery County).**

This Act will strengthen protections for vulnerable adults by authorizing local departments of social services to request assistance from federal law enforcement officers during investigations and by expanding provisions relating to the disclosure of information in adult protective services cases. By allowing disclosure to adult protective services, this Act ensures that necessary information can be shared with relevant agencies. Timely and accurate information sharing is pivotal for thorough investigations, coordinated responses, and effective interventions.

Because vulnerable adults—those who may be elderly, disabled, or otherwise unable to advocate for themselves—often face unique risks, including abuse, neglect, and exploitation, the provisions of this law are critical to ensuring their safety and well-being. In her testimony in support of this bill, Tammy Bresnahan, Senior Associate State Director for Advocacy, Maryland AARP, stated “protecting vulnerable adults is not merely a legal obligation; it is a moral imperative. Many adults who fall under the protection of adult protective services lack the capacity or resources to safeguard themselves from harm. By enabling local departments to leverage federal law enforcement resources, this bill closes critical gaps in investigative and protective efforts, especially in cases involving interstate or international elements. By passing this legislation, Maryland will reaffirm its commitment to protecting its most vulnerable residents. This bill demonstrates a proactive approach to addressing abuse and neglect and sends a clear message that we are unified in our efforts to hold perpetrators accountable while prioritizing the safety of those at risk.”

More senior consumer protection legislative proposals are expected in the 2026 Maryland General Assembly session.

## September Members Meeting Debriefing

An enthusiastic group of more than fifty people (combined in-person NARFE members, friends, guests, and online participants) gathered on September 30<sup>th</sup>, for our first official meeting under our new name, Greater Montgomery County Chapter 1892.

Three NARFE chapters have merged with Chapter 1892 Aspen Hill and a show of hands revealed a good mix of members from all the former chapters (Western Montgomery, Wheaton/Glenmont, and White Oak) and from Aspen Hill.

Members were encouraged informally to exchange ideas about how the now enlarged chapter should move forward. This meeting was an opportunity for attendees to present, discuss, and develop ideas to move forward. Four breakout groups were identified, and brainstorming worksheets were supplied to aid in guiding the group discussions.

Following approximately forty minutes of group discussions, attendees reconvened. Representatives from each breakout group reported their discussions.

Group 1 put forward a list of places for meetings that yielded pro-and-con comments: restaurants, churches, synagogues, social clubs, and recreation centers. Points to consider for any site noted having ample meeting space, distance to travel, access to public transportation, and parking.

Group 2 prefaced that programs should fulfill NARFE's mission and specifically, programs featuring issues affecting seniors. Suggesting a speaker from Montgomery Public Libraries concerning library system programs; speakers who could provide information on county services such as fraud prevention; someone with technical knowledge to talk about artificial intelligence (AI);

an advisor to address age-related matters including estate planning, wills, trusts, long-term care insurance, medical directives, Medicaid, and Thrift Savings Plan decisions; and how to do more advocating for federal employees and retirees, like a presentation which could feature NARFE representatives to report on what is being done regarding advocacy. Other ideas were presented as well: a speaker from the Montgomery County Recycle Center with information as to what can be recycled and what to do with batteries; a talk by the fire department about fire prevention and home safety, disposing of unused or outdated drugs and rescue squad issues. More lighthearted suggestions also were made such as museum trips and tours, learning about events at Montgomery Parks, the Historical Society, and Peerless Rockville. And "fun meetings" could be considered such as a Bingo game with prizes perhaps solicited from local businesses.

Group 3 offered suggestions that displaced federal workers may use. One step is that a displaced federal worker should obtain copies of her/his personnel records from the employee's human resources office. Contact NARFE to learn about new employment opportunities. Furthermore, contact offices of Senators and Representatives to inquire about programs available to displaced federal workers. Also, mentioning that there is a lot online from local libraries, for example, announcements of job fairs.

Group 4 commented about meeting electronics, such as not having a moving camera, not seeing or hearing people at a meeting when online, and the amount of time for meeting breaks being too long. Moreover, the capability of the current system may need to be examined, for example, adding more microphones. Online participants reported that at the beginning of each meeting, the moderator should remind all members tuning in by Zoom to mute themselves to stop background chatter, to identify themselves, to use their full names for the attendance list, and turn on Chat for online communication. They also commented that breaks are too lengthy.
